- 31 (3) (a) No later than October 1, 2024, the state department shall
- 32 convene an implementation team that shall create a plan UTILIZING THE

1 RECOMMENDATIONS FROM THE LEADERSHIP TEAM, AS APPROPRIATE, to
2 implement the system of care for children and youth who have complex
3 behavioral health needs.
4 (7) (b) Beginning January 2025, and each quarter thereafter, the
5 state department shall report progress on the development and
6 implementation of the system of care developed pursuant to this section
7 to the joint budget committee, THE IMPLEMENTATION TEAM, THE
8 LEADERSHIP TEAM, THE SENATE HEALTH AND HUMAN SERVICES
9 COMMITTEE, AND THE HOUSE OF REPRESENTATIVES HEALTH AND HUMAN
10 SERVICES COMMITTEE. THE REPORT REQUIRED BY THIS SUBSECTION (7)(b)
11 MUST INCLUDE THE RATIONALE FOR ANY RECOMMENDATION FROM THE
12 LEADERSHIP TEAM THAT THE DEPARTMENT ELECTS NOT TO IMPLEMENT.
