SENATE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 13, strike lines 6 through 27 and substitute:

2           "(7.5) (a) A TRANSPORTATION NETWORK COMPANY:  
3           (I) SHALL ENSURE THAT A DRIVER OR RIDER MAY OPT IN TO AUDIO  
4 AND VIDEO RECORDING OF EACH PREARRANGED RIDE IN ACCORDANCE  
5 WITH RULES ADOPTED BY THE COMMISSION PURSUANT TO SUBSECTION  
6 (7.5)(b) OF THIS SECTION; AND  
7           (II) SHALL NOT CHARGE A FEE OR INCREASE THE COST OF A  
8 PREARRANGED RIDE FOR A RIDER WHO OPTS IN TO AUDIO AND VIDEO  
9 RECORDING PURSUANT TO THIS SUBSECTION (7.5)."

10 Page 14, strike lines 1 through 5 and substitute:

11           "(b) ON OR BEFORE NOVEMBER 1, 2025, THE COMMISSION SHALL  
12 ADOPT RULES:  
13           (I) ESTABLISHING REQUIREMENTS AND PROCEDURES FOR AUDIO  
14 AND VIDEO RECORDING OF A PREARRANGED RIDE CONDUCTED PURSUANT  
15 TO SUBSECTION (7.5)(a) OF THIS SECTION, INCLUDING RULES REGARDING:  
16           (A) THE DEADLINES FOR IMPLEMENTATION OF AUDIO AND VIDEO  
17 RECORDING;  
18           (B) ACCESS TO, STORAGE OF, AND ENCRYPTION OF AUDIO AND  
19 VIDEO RECORDING;  
20           (C) TRANSFERRING AUDIO AND VIDEO RECORDING AND RELATED  
21 DATA BETWEEN A TRANSPORTATION NETWORK COMPANY AND THE DRIVER  
22 OR RIDER;  
23           (D) NOTIFICATION BY A TRANSPORTATION NETWORK COMPANY TO  
24 A DRIVER AND RIDER THAT A PREARRANGED RIDE IS CONTINUOUSLY AUDIO  
25 AND VIDEO RECORDED; AND  
26           (E) EDUCATION PROVIDED BY A TRANSPORTATION NETWORK  
27 COMPANY TO A DRIVER AND RIDER REGARDING THE SAFETY BENEFITS OF  
28 AUDIO AND VIDEO RECORDING OF A PREARRANGED RIDE;"
