Committee on Business Affairs & Labor.

HB25-1291 be amended as follows:

1 Amend proposed committee amendment (HB1291_L.001), page 3, line
2 10, strike "and (7.7)" and substitute "(7.7), and (11)".

3 Page 7, strike lines 24 through 29.

4 Page 7, after line 32 insert:

5 "(11) SUBSECTIONS (3)(c)(VII), (3)(c)(IX), (3)(d), (3)(e), (7)(c),
6 (7.5), AND (7.7) OF THIS SECTION DO NOT APPLY TO A TRANSPORTATION
7 NETWORK COMPANY THAT:

8 (a) EITHER SERVES RIDERS AT LEAST SEVENTY-FIVE PERCENT OF
9 WHOM ARE UNDER THE AGE OF EIGHTEEN OR EARNS AT LEAST NINETY
10 PERCENT OF THE TRANSPORTATION NETWORK COMPANY'S REVENUE FROM
11 CONTRACTS WITH A PUBLIC OR PRIVATE SCHOOL, THE FEDERAL
12 GOVERNMENT, THE STATE, OR AN AGENCY OR A POLITICAL SUBDIVISION OF
13 THE FEDERAL GOVERNMENT OR OF THE STATE; AND

14 (b) HAS AT LEAST NINETY PERCENT OF THE TRANSPORTATION
15 NETWORK COMPANY'S DRIVERS IN COMPLIANCE WITH THE COMMISSION'S
16 RULES PROMULGATED PURSUANT TO SECTION 40-10.1-608 (3)(a).".

17 Page 7, line 33, after "(3)" insert "and (4)".

18 Page 8, after line 14 insert:

19 "(4) SUBSECTION (3) OF THIS SECTION DOES NOT APPLY TO A
20 TRANSPORTATION NETWORK COMPANY THAT:

21 (a) EITHER SERVES RIDERS AT LEAST SEVENTY-FIVE PERCENT OF
22 WHOM ARE UNDER THE AGE OF EIGHTEEN OR EARNS AT LEAST NINETY
23 PERCENT OF THE TRANSPORTATION NETWORK COMPANY'S REVENUE FROM
24 CONTRACTS WITH A PUBLIC OR PRIVATE SCHOOL, THE FEDERAL
25 GOVERNMENT, THE STATE, OR AN AGENCY OR A POLITICAL SUBDIVISION OF
26 THE FEDERAL GOVERNMENT OR OF THE STATE; AND

27 (b) HAS AT LEAST NINETY PERCENT OF THE TRANSPORTATION
28 NETWORK COMPANY'S DRIVERS IN COMPLIANCE WITH THE COMMISSION'S
29 RULES PROMULGATED PURSUANT TO SECTION 40-10.1-608 (3)(a).".
