SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

HB25-1009 be amended as follows:

1 Amend reengrossed bill, page 4, line 3, after "PURPOSES." insert  
2 ""PRIVATELY OWNED REAL PROPERTY" OR "PROPERTY" DOES NOT MEAN  
3 REAL PROPERTY OWNED OR OCCUPIED BY A PUBLIC UTILITY THAT HAS A  
4 VEGETATION MANAGEMENT OR WILDFIRE MITIGATION PLAN TO ADDRESS  
5 VEGETATIVE FUEL SOURCES OR REAL PROPERTY ADJACENT TO A DITCH  
6 THAT CONVEYS DECREED WATER RIGHTS OR WITHIN THE APPURTENANT  
7 EASEMENT WITHIN WHICH THE DITCH IS LOCATED.".

8 Page 5, line 16, after "FINE." insert "A FIRE PROTECTION DISTRICT MAY  
9 NOT ACCESS ANY PRIVATELY OWNED REAL PROPERTY PURSUANT TO THIS  
10 SUBSECTION (1)(i)(II) WITHOUT THE WRITTEN PERMISSION OF THE OWNER  
11 OR OCCUPIER OF THE PROPERTY. AN OWNER OR OCCUPIER IS NOT LIABLE  
12 TO A FIRE PROTECTION DISTRICT FOR DAMAGES TO FIRE PROTECTION  
13 DISTRICT PERSONNEL OR EQUIPMENT OCCURRING ON THE PRIVATELY  
14 OWNED REAL PROPERTY WHILE FIRE PROTECTION DISTRICT PERSONNEL OR  
15 EQUIPMENT ARE PRESENT ON THE PROPERTY TO CARRY OUT THE PURPOSES  
16 OF THIS SECTION.".

17 Page 6, line 9, strike "OR".

18 Page 6, line 12, strike "FINE." and substitute "FINE; OR".

19 Page 6, after line 12, insert:

20 "(D) A WAIVER IS APPROPRIATE UNDER THE CIRCUMSTANCES.".

21 Page 6, line 14, strike "SHALL NOT ASSESS A" and substitute "MAY CAUSE  
22 A DELINQUENT CHARGE MADE OR LEVIED TO BE CERTIFIED TO THE  
23 TREASURER OF THE COUNTY AND BE COLLECTED AND PAID OVER BY THE  
24 TREASURER OF THE COUNTY IN THE SAME MANNER AS TAXES ARE  
25 AUTHORIZED TO BE BY TITLE 31.".

26 Page 6, strike lines 15 through 21.
