

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

1 HB25-1161 be amended as follows:

2 Amend reengrossed bill, strike everything below the enacting clause and  
3 substitute:

4 "SECTION 1. In Colorado Revised Statutes, **add** part 16 to  
5 article 5 of title 25 as follows:

6 PART 16

7 LABELING OF GAS-FUELED STOVES

8 **25-5-1601. Definitions.** AS USED IN THIS PART 16, UNLESS THE  
9 CONTEXT OTHERWISE REQUIRES:

10 (1) "DEPARTMENT" MEANS THE DEPARTMENT OF PUBLIC HEALTH  
11 AND ENVIRONMENT CREATED IN SECTION 25-1-102.

12 (2) "GAS-FUELED STOVE" MEANS A HOUSEHOLD STOVE, RANGE, OR  
13 COOKTOP THAT DIRECTLY COMBUSTS A GASEOUS OR LIQUID FUEL, IS USED  
14 FOR INDOOR FOOD PREPARATION, AND PROVIDES AT LEAST ONE OF THE  
15 FOLLOWING FUNCTIONS:

16 (a) SURFACE COOKING;

17 (b) OVEN COOKING; OR

18 (c) BROILING.

19 **25-5-1602. Labeling requirements - public information on the**  
20 **department's website.** (1) (a) A RETAILER SHALL NOT SELL, ATTEMPT TO  
21 SELL, OR OFFER TO SELL, IN A STORE, A NEW GAS-FUELED STOVE TO A  
22 POTENTIAL CONSUMER IN THE STATE UNLESS A YELLOW ADHESIVE LABEL  
23 ON THE DISPLAY MODEL FOR THE GAS-FUELED STOVE BEARS THE  
24 FOLLOWING STATEMENT IN BOLD-FACED, BLACK TYPE THAT IS CLEARLY  
25 LEGIBLE IN ENGLISH AND SPANISH:

26 **UNDERSTAND THE AIR QUALITY IMPLICATIONS OF**  
27 **HAVING AN INDOOR GAS STOVE.**

28 (b) FOLLOWING THE STATEMENT DESCRIBED IN SUBSECTION (1)(a)  
29 OF THIS SECTION, THE ADHESIVE LABEL MUST INCLUDE A WEBSITE LINK OR  
30 A QUICK RESPONSE (QR) CODE OR OTHER MACHINE-READABLE CODE THAT  
31 A POTENTIAL CONSUMER MAY USE TO ACCESS THE WEB PAGE ESTABLISHED  
32 BY THE DEPARTMENT PURSUANT TO SUBSECTION (4) OF THIS SECTION.

33 (2) A RETAILER SHALL AFFIX THE ADHESIVE LABEL DESCRIBED IN  
34 SUBSECTION (1) OF THIS SECTION TO THE DISPLAY MODEL FOR A NEW  
35 GAS-FUELED STOVE ON A HORIZONTAL SURFACE IN A PROMINENT POSITION  
36 THAT IS CAPABLE OF BEING EASILY READ BY A POTENTIAL CONSUMER  
37 EXAMINING THE DISPLAY MODEL AND EASILY ACCESSIBLE BY A CELL  
38 PHONE CAMERA.

39 (3) BEFORE TRANSACTING AN ONLINE SALE OF A NEW GAS-FUELED  
40 STOVE TO AN ADDRESS IN THE STATE, A RETAILER SHALL PROMINENTLY  
41 POST ON THE INTERNET WEBSITE WHERE THE ONLINE SALE OCCURS THE

1     CONTENT OF THE ADHESIVE LABEL DESCRIBED IN SUBSECTION (1) OF THIS  
2     SECTION FOR THE POTENTIAL CONSUMER.

3             (4)   THE DEPARTMENT SHALL ESTABLISH A PAGE ON THE  
4     DEPARTMENT'S PUBLIC WEBSITE WITH INFORMATION ON THE HEALTH  
5     IMPACTS OF GAS-FUELED STOVES. THE DEPARTMENT MAY INCLUDE ON THE  
6     WEB PAGE LINKS TO TECHNICAL STUDIES OR OTHER RESOURCES TO ASSIST  
7     THE PUBLIC IN UNDERSTANDING THE HEALTH IMPACTS OF GAS-FUELED  
8     STOVES.

9             **25-5-1603. Enforcement.** A RETAILER THAT, IN THE COURSE OF  
10    THE RETAILER'S BUSINESS, VIOLATES SECTION 25-5-1602 COMMITS A  
11    DECEPTIVE TRADE PRACTICE UNDER THE "COLORADO CONSUMER  
12    PROTECTION ACT", ARTICLE 1 OF TITLE 6.

13            **SECTION 2.** In Colorado Revised Statutes, 6-1-105, **add** (1)(iiii)  
14    as follows:

15            **6-1-105. Unfair or deceptive trade practices - definitions.**

16    (1) A person engages in a deceptive trade practice when, in the course of  
17    the person's business, vocation, or occupation, the person:

18            (iiii) VIOLATES SECTION 25-5-1602.

19            **SECTION 3. Act subject to petition - effective date -**  
20    **applicability.** (1) This act takes effect at 12:01 a.m. on the day following  
21    the expiration of the ninety-day period after final adjournment of the  
22    general assembly; except that, if a referendum petition is filed pursuant  
23    to section 1 (3) of article V of the state constitution against this act or an  
24    item, section, or part of this act within such period, then the act, item,  
25    section, or part will not take effect unless approved by the people at the  
26    general election to be held in November 2026 and, in such case, will take  
27    effect on the date of the official declaration of the vote thereon by the  
28    governor.

29            (2) This act applies to conduct occurring on or after the applicable  
30    effective date of this act."
