SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB23-011 be amended as follows:

- 1 Amend printed bill, page 3, line 22, strike "THE:" and substitute "THE  
2 ACTUAL COST TO PARTICIPATE IN:".
- 3 Page 3, line 23, strike "THIRTY-HOUR" and substitute "A THIRTY-HOUR".
- 4 Page 4, line 4, strike "EXPENSE," and substitute "EXPENSE, OR THE  
5 INDIVIDUAL'S PARENT OR GUARDIAN IF THE INDIVIDUAL DOES NOT FILE A  
6 TAX RETURN,".
- 7 Page 4, strike lines 16 and 17 and substitute "INCOME TAX YEAR  
8 COMMENCING ON OR AFTER JANUARY 1, 2023. WHEN THE CUMULATIVE  
9 EFFECT OF INFLATION HAS DEVALUED THE MAXIMUM AMOUNT THAT MAY  
10 BE CLAIMED BY ONE HUNDRED DOLLARS, THE DEPARTMENT SHALL  
11 INCREASE THE MAXIMUM AMOUNT THAT MAY BE CLAIMED BY ONE  
12 HUNDRED DOLLARS.".
- 13 Page 4, strike lines 21 through 24.
- 14 Renumber succeeding subsections accordingly.
- 15 Page 7, strike line 1 and substitute "TWENTY-ONE YEARS OF AGE UNLESS:  
16 (a) THE PERSON HAS BEEN ISSUED A DRIVER'S LICENSE FROM  
17 ANOTHER JURISDICTION; OR  
18 (b) THE PERSON HAS SUCCESSFULLY".
- 19 Page 7, line 11, strike "COMPLETED" and substitute "COMPLETED, WITHIN  
20 THE PREVIOUS SIX MONTHS,".
- 21 Page 8, line 10, strike "COLORADO" and substitute "VALID".
- 22 Page 8, lines 16 and 17, strike "COSIGNED THE APPLICATION FOR THE  
23 MINOR'S INSTRUCTION PERMIT;" and substitute "SIGNED THE AFFIDAVIT OF  
24 LIABILITY;".
- 25 Page 8, lines 18 and 19, strike "COSIGNED THE APPLICATION FOR THE  
26 MINOR'S INSTRUCTION PERMIT;" and substitute "SIGNED THE AFFIDAVIT OF  
27 LIABILITY;".
- 28 Page 8, strike lines 21 and 22 and substitute "VEHICLE COMPLIES WITH  
29 SECTION 42-2-602;".

- 1 Page 8, line 24, strike "OR".
- 2 Page 8, line 26, strike "SECTION." and substitute "SECTION; OR  
3 (H) THE PERSON WHO SIGNED THE AFFIDAVIT OF LIABILITY.".
- 4 Page 9, strike lines 9 through 11 and substitute "ATTORNEY, GUARDIAN  
5 WHO SIGNED THE AFFIDAVIT OF LIABILITY, OR FOSTER PARENT WHO SIGNED  
6 THE AFFIDAVIT OF LIABILITY MAY ALLOW THE".
- 7 Page 10, line 9, strike "FROM COLORADO".
- 8 Page 10, strike line 11 and substitute "COLORADO STATE PATROL.".
- 9 Page 12, line 13, strike "BEHIND-THE-WHEEL".
- 10 Page 12, line 21, strike "DRIVING".
- 11 Page 12, line 27, strike "BEHIND-THE-WHEEL".
- 12 Page 13, line 6, strike "BEHIND-THE-WHEEL".
- 13 Page 13, line 8, strike "BEHIND-THE-WHEEL".
- 14 Page 13, strike lines 17 through 24 and substitute "RECORD CHECK. THE  
15 COLORADO BUREAU OF INVESTIGATION SHALL FORWARD THE RESULTS TO  
16 THE COMMERCIAL DRIVING SCHOOL. A COMMERCIAL DRIVING SCHOOL  
17 MAY ACQUIRE A NAME-BASED JUDICIAL RECORD CHECK FOR A  
18 COMMERCIAL DRIVING INSTRUCTOR WHO HAS TWICE SUBMITTED TO A  
19 FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK AND WHOSE  
20 FINGERPRINTS ARE UNCLASSIFIABLE. THE COMMERCIAL DRIVING SCHOOL  
21 SHALL NOTIFY THE DEPARTMENT OF ANY CRIMINAL CONVICTION OR PLEA  
22 OF GUILTY".
- 23 Page 14, strike lines 5 through 13 and substitute "**applicability.** (1) This  
24 act takes effect July 1, 2024; except that, if a referendum petition is filed  
25 pursuant to section 1 (3) of article V of the state constitution against this  
26 act or an item, section, or part of this act within the ninety-day period  
27 after final adjournment of the general assembly, then the act, item,  
28 section, or part will not take effect unless approved by the people at the  
29 general election to be held in November 2024 and, in such case, will take  
30 effect on the date of the official declaration of the vote thereon by the  
31 governor.".
