

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB21-1189 be amended as follows:

1 Amend printed bill, page 4, strike lines 12 through 20 and substitute:

2        "(b)(c) "Covered facility" means a stationary source that ~~reported~~  
3 ~~at least one of the following amounts of a covered air toxic in its federal~~  
4 ~~toxics release inventory filing pursuant to 42 U.S.C. sec. 11023 for the~~  
5 ~~year 2017 or later~~ IS COVERED BY ONE OF THE FOLLOWING NORTH  
6 AMERICAN INDUSTRY CLASSIFICATION SYSTEM CODES ESTABLISHED BY  
7 THE FEDERAL OFFICE OF MANAGEMENT AND BUDGET:

8        (I) ~~For hydrogen cyanide, ten thousand pounds~~ 324110,  
9 "PETROLEUM REFINERIES";

10        (II) ~~For hydrogen sulfide, five thousand pounds, and~~ 336413,  
11 "OTHER AIRCRAFT PARTS AND AUXILIARY EQUIPMENT MANUFACTURING";

12        (III) ~~For benzene, one thousand pounds;~~ 424710, "PETROLEUM  
13 BULK STATIONS AND TERMINALS", IF THE SOURCE IS WITHIN AN  
14 EIGHT-HOUR OZONE CONTROL AREA AND HAS REPORTED EMISSIONS OF  
15 BENZENE IN ITS FEDERAL TOXICS RELEASE INVENTORY FILING PURSUANT  
16 TO 42 U.S.C. SEC. 11023 FOR THE YEARS 2017 THROUGH 2019, AS OF JULY  
17 1, 2020; OR

18        (IV) ANY OTHER CODE LISTED BY RULE PURSUANT TO SUBSECTION  
19 (3) OF THIS SECTION.".

20 Page 7, line 1, strike "**emission thresholds**" and substitute "**industry**  
21 **codes**".

22 Page 7, lines 7 and 8, strike "EMISSION THRESHOLDS" and substitute  
23 "NORTH AMERICAN INDUSTRY CLASSIFICATION SYSTEM CODES".

24 Page 7, strike lines 10 and 11 and substitute "AIR TOXICS AND WHETHER  
25 ANY ADDITIONAL STATIONARY SOURCES SHOULD BE INCLUDED AS  
26 COVERED FACILITIES; AND".

27 Page 7, line 13, strike everything after "COVERED" and substitute  
28 "FACILITIES".

29 Page 7, strike line 14.
