Committee on Appropriations.

SB24-076 be amended as follows:

- 1 Amend the Finance Committee Report, dated March 5, 2024, page 1,

  - 21 AUTHORITY MAY DETERMINE WHETHER EACH TYPE OF LICENSE, INCLUDING
  - 22 AN ASSOCIATED MARIJUANA DELIVERY PERMIT, ISSUED BY THE LOCAL
  - 23 LICENSING AUTHORITY IS VALID FOR ONE OR TWO YEARS."."

- 17   Page 5 of the report, line 25, strike "(IV)" and substitute "(III)".
- 18   Page 5 of the report, line 26, strike "OUTSIDE OF" and substitute "ONLY  
19   ON".
- 20   Page 5 of the report, line 28, strike "after line 5" and substitute "before  
21   line 6".
