Committee on Finance.

SB24-076 be amended as follows:

- 1 Amend printed bill, page 3, line 9, strike "PLANTS;" and substitute
- 2 "PLANTS CONTAINING A DELTA-9 TETRAHYDROCANNABINOL
- 3 CONCENTRATION OF NO MORE THAN THREE-TENTHS OF ONE PERCENT ON
- 4 A DRY WEIGHT BASIS;".
- 5 Page 4, line 6, strike "(2)(d)(I), (2)(d)(II), (2)(d)(III)," and substitute
- 6 "(2)(d)(III)(A), (2)(d)(III)(B),".
- 7 Page 4, line 7, strike "(2)(dd)(XIV), (9)(a), and (9)(b)(I);" and substitute
- 8 "and (2)(dd)(XIV);".
- 9 Page 4, strike lines 12 through 26.
- 10 Page 4, line 27, before "(III)" insert "(d)".
- 11 Page 5, line 1, strike "IN AN AMOUNT THAT IS".
- 12 Page 5, lines 13 and 14, strike "~~quantities of any~~ A substance IN AN
- 13 AMOUNT THAT IS" and substitute "quantities of ~~any~~ A substance".
- 14 Page 5, strike lines 17 through 20.
- 15 Page 5, line 22, strike "~~and frequency~~" and substitute "and frequency".
- 16 Page 6, lines 17 and 18, strike "FEE, NOT TO EXCEED FOUR THOUSAND
- 17 DOLLARS PER FACILITY," and substitute "FEE".
- 18 Page 8, line 3, strike "SECTION," and substitute "SECTION, ON AND AFTER
- 19 JANUARY 1, 2027,".
- 20 Page 8, strike lines 6 through 25.
- 21 Renumber succeeding sections accordingly.
- 22 Page 9, line 1, after "(b)" insert "(I)".
- 23 Page 9, after line 7 insert:
- 24 "(II) (A) THIS SUBSECTION (6)(b) APPLIES TO LICENSES ISSUED
- 25 AFTER THE EFFECTIVE DATE OF THIS SECTION, AS AMENDED.
- 26 (B) THIS SUBSECTION (6)(b)(II) IS REPEALED, EFFECTIVE JULY 1,

1 2026".

2 Page 9, lines 8 and 9, strike "**amend** (2); and".

3 Page 9, strike lines 11 through 27 and substitute "**rules. (3)** A LICENSE
4 ISSUED BY THE STATE LICENSING AUTHORITY UNDER THIS ARTICLE 10
5 EXPIRES TWO YEARS AFTER ISSUANCE; EXCEPT THAT A PERSON THAT
6 HOLDS MULTIPLE LICENSES MAY ELECT TO HAVE ONE OR MORE LICENSES
7 EXPIRE IN LESS".

8 Page 10, strike lines 6 through 15 and substitute:

9 "(4) ON OR AFTER JANUARY 1, 2026, THE STATE LICENSING
10 AUTHORITY SHALL PROMULGATE RULES AUTHORIZING MULTIPLE
11 REGULATED MARIJUANA BUSINESS LICENSEES WITH IDENTICAL
12 CONTROLLING BENEFICIAL OWNERS TO SUBMIT A SINGLE INITIAL
13 APPLICATION OR A SINGLE RENEWAL APPLICATION THROUGH A UNIFIED
14 APPLICATION PROCESS. THE STATE LICENSING AUTHORITY SHALL
15 PROMULGATE RULES SETTING STANDARDS AND REQUIREMENTS FOR
16 UNIFIED APPLICATION PROCESSING.".

18 Page 11, line 13, strike "TRANSFER OR DELIVER" and substitute "SELL,
19 TRANSFER, OR SHIP".

20 Page 11, strike lines 24 through 27 and substitute:

21 "(III) FOR SALES, TRANSFERS, OR SHIPMENTS TO AN INDIVIDUAL,
22 A MEDICAL MARIJUANA CULTIVATION FACILITY SHALL ESTABLISH
23 PROCESSES AND PROCEDURES TO CONFIRM THAT THE PURCHASING OR
24 RECEIVING INDIVIDUAL IS TWENTY-ONE YEARS OF AGE OR OLDER USING AN
25 AGE VERIFICATION PROCESS, SUCH AS AUTHENTICATION VERIFICATION,
26 BIOMETRIC VERIFICATION, OR DOCUMENT VERIFICATION. THE STATE
27 LICENSING AUTHORITY SHALL VERIFY COMPLIANCE WITH THIS
28 REQUIREMENT BY CONFIRMING THAT THE LICENSEE HAS ESTABLISHED THE
29 PROCESSES AND PROCEDURES REQUIRED UNDER THIS SUBSECTION
30 (7)(b)(III).".

31 Page 12, line 2, strike "TRANSFER OR DELIVERY" and substitute "SALE,
32 TRANSFER, OR SHIPMENT".

33 Page 12, after line 3 insert:

34 "(V) A LICENSED MEDICAL MARIJUANA CULTIVATION FACILITY

- 1 SHALL NOT TRANSFER GENETIC MATERIAL DIRECTLY TO CONSUMERS WHO
2 ARE PRESENT ON THE LICENSED PREMISES."
- 3 Page 12, line 6, strike "RECORD KEEPING, AND AGE VERIFICATION." and
4 substitute "AND RECORD KEEPING."
- 5 Page 12, line 7, after "RULES" insert "AND CONDUCTING ENFORCEMENT
6 ACTIONS".
- 7 Page 12, line 11, strike "POSSESSED BY" and substitute "ON THE LICENSED
8 PREMISES OF".
- 9 Page 12, line 17, strike "OR".
- 10 Page 12, line 20, strike "MATERIAL." and substitute "MATERIAL; OR
11 (IV) MONITOR OR TAKE ENFORCEMENT ACTION ASSOCIATED WITH
12 A LICENSEE'S GENETIC MATERIAL ACTIVITIES THAT OCCUR OUTSIDE OF THE
13 LICENSED PREMISES.
14 (d) THIS SUBSECTION (7) DOES NOT LIMIT THE APPLICABILITY OF
15 ANOTHER STATE'S LAW, THE APPLICABILITY OF FEDERAL LAW, OR
16 ENFORCEMENT BY FEDERAL AGENCIES."
- 17 Page 13, line 9, strike "and (12)(c)" and substitute "(12)(c), and (12)(d)".
- 18 Page 13, line 25, strike "TRANSFER OR DELIVER" and substitute "SELL,
19 TRANSFER, OR SHIP".
- 20 Page 14, strike lines 9 through 12 and substitute:
- 21 "(III) FOR SALES, TRANSFERS, OR SHIPMENTS TO AN INDIVIDUAL,
22 A RETAIL MARIJUANA CULTIVATION FACILITY SHALL ESTABLISH PROCESSES
23 AND PROCEDURES TO CONFIRM THAT THE PURCHASING OR RECEIVING
24 INDIVIDUAL IS TWENTY-ONE YEARS OF AGE OR OLDER USING AN AGE
25 VERIFICATION PROCESS, SUCH AS AUTHENTICATION VERIFICATION,
26 BIOMETRIC VERIFICATION, OR DOCUMENT VERIFICATION. THE STATE
27 LICENSING AUTHORITY SHALL VERIFY COMPLIANCE WITH THIS
28 REQUIREMENT BY CONFIRMING THAT THE LICENSEE HAS ESTABLISHED THE
29 PROCESSES AND PROCEDURES REQUIRED UNDER THIS SUBSECTION
30 (12)(b)(III)."
- 31 Page 14, line 14, strike "TRANSFER OR DELIVERY" and substitute "SALE,
32 TRANSFER, OR SHIPMENT".
- 33 Page 14, after line 15 insert:

- 1 "(V) A LICENSED RETAIL MARIJUANA CULTIVATION FACILITY
2 SHALL NOT TRANSFER GENETIC MATERIAL DIRECTLY TO CONSUMERS WHO
3 ARE PRESENT ON THE LICENSED PREMISES."
- 4 Page 14, line 18, strike "RECORD KEEPING, AND AGE VERIFICATION." and
5 substitute "AND RECORD KEEPING."
- 6 Page 14, line 19, after "RULES" insert "AND CONDUCTING ENFORCEMENT
7 ACTIONS".
- 8 Page 14, line 23, strike "POSSESSED BY" and substitute "ON THE LICENSED
9 PREMISES OF".
- 10 Page 15, line 2, strike "OR".
- 11 Page 15, line 5, strike "MATERIAL." and substitute "MATERIAL;
12 (IV) MONITOR OR TAKE ENFORCEMENT ACTION ASSOCIATED WITH
13 A LICENSEE'S GENETIC MATERIAL ACTIVITIES THAT OCCUR OUTSIDE OF THE
14 LICENSED PREMISES."
- 15 Page 15, after line 5 insert:
- 16 "(d) THIS SUBSECTION (12) DOES NOT LIMIT THE APPLICABILITY OF
17 ANOTHER STATE'S LAW, THE APPLICABILITY OF FEDERAL LAW, OR
18 ENFORCEMENT BY FEDERAL AGENCIES."
- 19 Page 15, strike lines 12 through 27.
- 20 Page 16, strike lines 1 through 8.
- 21 Renumber succeeding sections accordingly.
