

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB21-1115 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and  
2 substitute:

3       **"SECTION 1.** In Colorado Revised Statutes, 25-1-508, **add** (7),  
4 (8), (9), and (10) as follows:

5       **25-1-508. County or district boards of public health - public**  
6 **health directors.** (7) MEMBERS OF A COUNTY BOARD OF HEALTH OR A  
7 DISTRICT BOARD OF HEALTH SHALL ATTEND ANNUAL PUBLIC HEALTH  
8 TRAINING PROVIDED BY THE DEPARTMENT OF PUBLIC HEALTH AND  
9 ENVIRONMENT AND DEVELOPED BY THE DEPARTMENT OF PUBLIC HEALTH  
10 AND ENVIRONMENT ALONG WITH THE COLORADO SCHOOL OF PUBLIC  
11 HEALTH.

12       (8) THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT  
13 SHALL PROVIDE GUIDANCE ON RECRUITING PERSONS WHO ARE ELIGIBLE  
14 AND WILLING TO SERVE ON COUNTY AND DISTRICT BOARDS OF HEALTH.  
15 THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT SHALL PROVIDE  
16 THE GUIDANCE IN AN ELECTRONIC FORMAT TO ANY BOARD OF COUNTY  
17 COMMISSIONERS, COUNTY BOARD OF HEALTH, OR DISTRICT BOARD OF  
18 HEALTH THAT REQUESTS IT.

19       (9) IF A COUNTY BOARD OF HEALTH POLICY DOES NOT COMPLY  
20 WITH PUBLIC HEALTH ORDERS AND GUIDELINES PROMULGATED BY THE  
21 DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT WITHIN FOURTEEN  
22 DAYS OF THE COUNTY BOARD OF HEALTH RECEIVING SUCH ORDERS OR  
23 GUIDELINES, THE BOARD OF COUNTY COMMISSIONERS MAY NOT BE  
24 DESIGNATED AS THE COUNTY BOARD OF HEALTH AND INSTEAD, THE  
25 COUNTY BOARD OF HEALTH MUST BE COMPOSED IN ACCORDANCE WITH  
26 THE REQUIREMENTS OF SUBSECTION (2)(a) AND (2)(b) OF THIS SECTION.

27       (10) CHANGES TO THIS SECTION MADE BY HOUSE BILL 21-1115,  
28 ENACTED IN 2021, TAKE EFFECT JANUARY 1, 2022.

29       **SECTION 2. Act subject to petition - effective date.** This act  
30 takes effect at 12:01 a.m. on the day following the expiration of the  
31 ninety-day period after final adjournment of the general assembly; except  
32 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
33 of the state constitution against this act or an item, section, or part of this  
34 act within such period, then the act, item, section, or part will not take  
35 effect unless approved by the people at the general election to be held in  
36 November 2022 and, in such case, will take effect on the date of the  
37 official declaration of the vote thereon by the governor."
