

1 Amend the Finance Committee Report, dated March 29, 2021, page 1,
2 strike lines 13 and 14 and substitute:

3 "Page 11 of the printed bill, strike line 8 and substitute "(1)(b) AND (2) OF
4 THIS SECTION, A RETAIL".

5 Page 11 of the bill, line 11, after the period add "THE PROHIBITION DOES
6 NOT GO INTO EFFECT UNTIL AFTER THE EXECUTIVE DIRECTOR OF THE
7 DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT CERTIFIES THAT THE
8 STATE HAS REACHED A MINIMUM TWENTY-FIVE PERCENT STATEWIDE
9 RECYCLING RATE. THE DEPARTMENT SHALL NOTIFY ALL COUNTY OR
10 DISTRICT PUBLIC HEALTH AGENCIES, AS DEFINED IN SECTION 25-4-1602
11 (2.5), OF THE CERTIFICATION AND SHALL POST THE CERTIFICATION ON THE
12 DEPARTMENT'S PUBLIC WEBSITE. ON THE NEXT NOTICE THAT THE
13 DEPARTMENT OR A COUNTY OR DISTRICT PUBLIC HEALTH AGENCY
14 PROVIDES A RETAIL FOOD ESTABLISHMENT ASSESSING THAT RETAIL FOOD
15 ESTABLISHMENT A LICENSE FEE PURSUANT TO SECTION 25-4-1607, THE
16 DEPARTMENT OR THE COUNTY OR DISTRICT PUBLIC HEALTH AGENCY SHALL
17 NOTIFY THE RETAIL FOOD ESTABLISHMENT THAT THE RETAIL FOOD
18 ESTABLISHMENT IS REQUIRED TO COMPLY WITH THE PROHIBITION.".

19 Page 11 of the bill, line 16, strike "JANUARY 1, 2023," and substitute
20 "TWO YEARS AFTER THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF
21 PUBLIC HEALTH AND ENVIRONMENT CERTIFIES THAT THE STATE HAS
22 REACHED A TWENTY-FIVE PERCENT STATEWIDE RECYCLING RATE
23 PURSUANT TO SUBSECTION (1) OF THIS SECTION,".".

24 Page 2 of the report, strike line 1 and substitute:

25 "Page 11 of the bill, line 19, strike "JANUARY 1, 2024," and substitute
26 "THREE YEARS AFTER THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF
27 PUBLIC HEALTH AND ENVIRONMENT CERTIFIES THAT THE STATE HAS
28 REACHED A TWENTY-FIVE PERCENT STATEWIDE RECYCLING RATE
29 PURSUANT TO SUBSECTION (1) OF THIS SECTION,".".

30 Page 2 of the report, after line 3 insert:

31 "Page 11 of the bill, line 21, strike "JANUARY 1, 2022," and substitute "ITS
32 COMPLIANCE WITH SUBSECTION (1) OF THIS SECTION IS REQUIRED,".".
