3 **SECTION 6.** In Colorado Revised Statutes, 22-5-106, **amend**
4 (1)(b) as follows:

5 **22-5-106. Financing, budgeting, and accounting.** (1) (b) A
6 board of cooperative services may finance all or a portion of the costs of
7 an approved career and technical education program from funds received
8 pursuant to PART 1 OF article 8 of title 23.

9 **SECTION 7.** In Colorado Revised Statutes, 22-32-118, **amend**
10 (2)(b) as follows:

11 **22-32-118. Summer schools - continuation, evening, and**
12 **community education programs.** (2) (b) In addition to the authority
13 granted to a board of education in ~~paragraph (a) of this subsection~~ (2)
14 SUBSECTION (2)(a) OF THIS SECTION, a board may establish and maintain
15 community education programs in cooperation with any unit of local
16 government, quasi-governmental agency, institution of higher education,
17 or civic organization and may pay for such programs by a fee or tuition
18 charged or out of moneys of the school district. Attendance in community
19 education programs shall not be considered in computing pupil
20 enrollment under article 54 of this title and articles 8 and 60 TITLE 22 AND
21 PART 1 OF ARTICLE 8 AND ARTICLE 60 of title 23. C.R.S.

22 **SECTION 8.** In Colorado Revised Statutes, 22-38-115, **amend**
23 (2) as follows:

24 **22-38-115. Funding.** (2) A pilot school may have access to any
25 public or private funding sources available for vocational training,
26 including any funds available pursuant to PART 1 OF article 8 of title 23.

28 **SECTION 9.** In Colorado Revised Statutes, 22-54-107, **amend**
29 (3) as follows:

30 **22-54-107. Buy-out of categorical programs - total program**
31 **reserve fund levy.** (3) For purposes of this section, "categorical program
32 support funds that the district would otherwise be eligible to receive from
33 the state" means amounts that the district would have received from the
34 state but that will be received instead from property tax revenues by
35 reason of this section and includes funds pursuant to the "Exceptional
36 Children's Educational Act", article 20 of this title 22; funds pursuant to
37 the "English Language Proficiency Act", article 24 of this title 22;
38 transportation aid pursuant to article 51 of this title 22; small attendance
39 center aid pursuant to section 22-54-122; and career and technical
40 education aid pursuant to PART 1 OF article 8 of title 23. Funds received

1 by an administrative unit under the "Exceptional Children's Educational
2 Act", article 20 of this title 22, as reimbursement for services provided to
3 children counted in the pupil enrollment of a district are considered as
4 funds that a district would otherwise be eligible to receive for purposes
5 of this subsection (3).

6 **SECTION 10.** In Colorado Revised Statutes, 22-55-102, **amend**

8 **22-55-102. Definitions.** As used in this ~~article~~ ARTICLE 55, unless
9 the context otherwise requires:

10 (4) "Categorical programs" includes only the following programs:
11 (g) Career and technical education as described in PART 1 OF
12 article 8 of title 23; ~~C.R.S.~~;

13 **SECTION 11.** In Colorado Revised Statutes, 23-8-102, **amend**
14 (1) introductory portion, (1)(a), and (4) as follows:

15 **23-8-102. School districts, boards of cooperative services, and**
16 **institute charter schools conducting career and technical education**
17 **courses - eligibility for state money.** (1) An education provider of the
18 state conducting a course of career and technical education approved
19 pursuant to section 23-8-103 by the board is entitled to career and
20 technical education program support from ~~money~~ MONEY appropriated
21 for that purpose by the general assembly. The amount of career and
22 technical education program support that an education provider is entitled
23 to receive pursuant to ~~the provisions of this article~~ THIS PART 1 shall be
24 computed as follows:

25 (a) The cost of providing the approved career and technical
26 education programs of the education provider shall be computed in
27 accordance with paragraph (c) of this subsection (1) SUBSECTION (1)(c)
28 OF THIS SECTION. The cost so computed shall be divided by the number of
29 full-time equivalent students to be served by the programs, and the result
30 shall be designated, for purposes of this ~~article~~ PART 1, as the education
31 provider's career and technical education program cost per full-time
32 equivalent student.

33 (4) ~~Money~~ MONEY made available under this ~~article~~ PART 1 shall
34 be distributed quarterly on the basis of the report of actual expenditures
35 furnished to the board by participating education providers at the end of
36 the previous fiscal year. As soon as practicable after July 1 of each year,
37 beginning in 1971, each participating education provider shall file with
38 the board a report of actual expenditures for all career and technical
39 education programs for which the education provider is eligible to receive
40 ~~money~~ MONEY pursuant to ~~the provisions of this article~~ THIS PART 1
41 during the preceding twelve-month period.

42 **SECTION 12.** In Colorado Revised Statutes, 23-8-103, **amend**

1 **23-8-103. Standards for eligibility for grants - rules.** (3) In
2 approving career and technical education programs and career and
3 technical education program support ~~moneys~~ MONEY under this article
4 PART 1, the board shall attempt to avoid unnecessary duplication in either
5 facilities or staffing for career and technical education in an education
6 provider or within an area of this state; and, where feasible, sharing of
7 facilities shall be required by the board.

8 (4) The board shall adopt such rules as may be necessary to
9 administer the provisions of this article THIS PART 1.
