3 Page 18, strike lines 3 through 23.

4 Reletter succeeding paragraph accordingly.

5 Page 21, line 3 and 4, strike "THROUGH RULE-MAKING PURSUANT TO
6 SECTION 44-10-203 (2)(jj)" and substitute "PURSUANT TO SECTION
7 44-10-202 (8)".

8 Page 24, line 12, strike "SECTION 44-10-203 (2)(jj)" and substitute
9 "SECTION 44-10-202 (8)".

10 Page 24, after line 17, insert:

11 **"SECTION 10.** In Colorado Revised Statutes, 44-10-202, **add** (8)
12 as follows:

13 **44-10-202. Powers and duties of state licensing authority -**
14 **stakeholder work group - rules - report - legislative declaration -**
15 **repeal.** (8) (a) THE STATE LICENSING AUTHORITY SHALL CONVENE A
16 STAKEHOLDER WORK GROUP TO DEVELOP:

17 (I) A UNIFORM CERTIFICATION FORM TO BE USED BY
18 RECOMMENDING PHYSICIANS WHEN AUTHORIZING THE PATIENT TO
19 PURCHASE MORE THAN THE STATUTORILY ALLOWED QUANTITIES, AS
20 REQUIRED BY SECTION 25-1.5-106 (5), WHICH MAY BE RELIED UPON BY
21 MEDICAL MARIJUANA STORES. THE FORM MUST CONTAIN A UNIFORM
22 WEIGHT AND UNIFORM POTENCY DESCRIPTION TO ENABLE A MEDICAL
23 MARIJUANA STORE TO FULFILL ITS OBLIGATIONS WITHOUT THE NEED TO
24 MAKE A FURTHER CALCULATION OR EXAMINE OTHER DOCUMENTS. THE
25 FORM SHALL NOT CONTAIN ANY INFORMATION CONCERNING THE PATIENT'S
26 MEDICAL CONDITION OR DIAGNOSIS; AND

27 (II) A TANGIBLE EDUCATIONAL RESOURCE REGARDING THE USE OF
28 REGULATED MARIJUANA CONCENTRATE. THE EDUCATIONAL RESOURCE
29 MUST PROVIDE INFORMATION AS DETERMINED BY RULE AND EDUCATION,
30 INCLUDING BUT NOT LIMITED TO:

31 (A) EXAMPLES OF VISUAL REPRESENTATION OF A SERVING SIZE
32 RECOMMENDED FOR EACH TYPE OF CONCENTRATE;

33 (B) RISKS AND PRECAUTIONS;

34 (C) OTHER STATUTORY AND REGULATORY LABELING
35 REQUIREMENTS MANDATED ON MARIJUANA PRODUCTS; AND

36 (D) A NOTICE THAT DESCRIBES THE PENALTIES ASSOCIATED WITH

1 MARIJUANA DIVERSION.

2 (b) THE UNIFORM CERTIFICATION AND EDUCATIONAL RESOURCE
3 MUST BE COMPLETED BY JANUARY 1, 2022.

4 (c) THIS SUBSECTION (8) IS REPEALED, EFFECTIVE JULY 1, 2022.".

5 Renumber succeeding sections accordingly.

6 Page 26, after line 3, insert:

7 **"SECTION 12. Effective date.** This act takes effect upon
8 passage; except that sections 2, 8, and 9 of the bill take effect on January
9 1, 2022.".

10 Renumber succeeding section accordingly.
