- 1 Amend the Appropriations Committee Report, dated May 25, 2021, page  
2 1, line 7, strike "STUDIES."." and substitute "STUDIES. NOTHING IN THIS  
3 SECTION SHALL PRECLUDE THE COLORADO SCHOOL OF PUBLIC HEALTH  
4 FROM MAKING RECOMMENDATIONS REGARDING APPROPRIATE  
5 REGULATORY MEASURES TO THE SCIENTIFIC REVIEW COUNCIL CREATED IN  
6 SUBSECTION (2)(b) OF THIS SECTION.".".
- 7 Page 1 of the committee report, strike lines 15 and 16 and substitute  
8 "MEETING AND THE MEETINGS MUST BE BROADCAST TO THE PUBLIC.  
9 NOTHING PRECLUDES THE PUBLIC FROM SUBMITTING WRITTEN COMMENTS  
10 TO THE COMMITTEE.".".
- 11 Page 2 of the committee report, after line 20 insert:  
12 "Page 9, line 7, strike "QUANTITY;" and substitute "QUANTITY, IF SUCH  
13 QUANTITY EXCEEDS THE MAXIMUM STATUTORILY ALLOWED AMOUNT FOR  
14 THE PATIENT'S AGE;".".
- 15 Page 5 of the committee report, after line 17 insert:  
16 "Page 17, strike lines 19 and 20 and substitute"EXCEED THE PATIENT'S  
17 DAILY AUTHORIZED QUANTITY LIMIT OR THE AMOUNT LISTED ON THE  
18 PATIENT'S CERTIFICATION, WHICHEVER IS GREATER, AND THE PURCHASE  
19 ALIGNS WITH THE PURCHASE AUTHORITY INFORMATION IN THE  
20 SEED-TO-SALE TRACKING SYSTEM.".
- 21 Page 18, line 11, strike "THE" and substitute "IF THE PATIENT SEEKS TO  
22 PURCHASE MORE THAN THE STATUTORILY ALLOWED DAILY AUTHORIZED  
23 LIMIT OF CONCENTRATE FOR THE PATIENT'S AGE GROUP, THE".".
- 24 Page 5 of the committee report, after line 19 insert:  
25 "Page 18, lines 18 through 20, strike "store; EXCEPT THAT THE  
26 LIMITATIONS IN SUBSECTION (13) OF THIS SECTION APPLY REGARDLESS OF  
27 THE AMOUNT IN THE PHYSICIAN EXEMPTION." and substitute "store.".".
