Committee on Education.

HB21-1067 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 20 through 27.
- 2 Page 4, strike lines 1 through 3 and substitute:

"(10.5) (a) (I) ON OR BEFORE JUNE 30, 2023, AND ON OR BEFORE JUNE 30 EACH YEAR THEREAFTER, THE DEPARTMENT OF EDUCATION SHALL PUBLISH AN ANNUAL REPORT INCLUDING:

 - 6 (A) WHICH STATE-SUPPORTED BACCALAUREATE AND GRADUATE INSTITUTIONS OF HIGHER EDUCATION REQUIRED, AND WHICH INSTITUTIONS DID NOT REQUIRE, A NATIONAL ASSESSMENT TEST SCORE AS AN ELIGIBILITY CRITERION FOR THE PREVIOUS ACADEMIC YEAR'S FIRST-TIME FRESHMAN COHORT;
 - 11 (B) THE PERCENTAGE OF FIRST-TIME FRESHMEN STUDENTS, BOTH STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND GENDER;
 - 15 (C) THE PERCENTAGE OF FIRST-TIME FRESHMEN STUDENTS, BOTH STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND GENDER, AND ENROLLED IN AN INSTITUTION;
 - 19 (D) THE PERCENTAGE OF STUDENTS, BOTH STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND GENDER, WHO ENROLLED IN THE INSTITUTION IN A SUBSEQUENT ACADEMIC YEAR;
 - 24 (E) THE PERCENTAGE OF STUDENTS, BOTH STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND GENDER, WHO GRADUATED FROM THE INSTITUTION;".
- 28 Reletter succeeding sub-subparagraphs accordingly.
- 29 Page 4, line 9, strike "CURRENT" and substitute "PREVIOUS".
- 30 Page 4, line 10, strike "INSTITUTION" and substitute "DEPARTMENT OF EDUCATION".
- 32 Page 4, line 20, strike "MARCH 1, 2022, AND ON OR BEFORE MARCH 1" and substitute "JUNE 30, 2023, AND ON OR BEFORE JUNE 30".
- 34 Page 4, line 24, strike "SECTION" and substitute "SECTION.".
- 35 Page 4, strike line 25.
