PURPOSE: Reduces the appropriation for Returned Mail Processing in the Department of **Health Care Policy and Financing** by \$85,800 General Fund. Adds \$85,800 General Fund and \$85,800 reappropriated

funds in the Department of **Higher Education** with a footnote specifying that this funding is for the University of Colorado Colorado Springs for allocation to the National Cybersecurity Center.
