

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB21-1287 be amended as follows:

1 Amend printed bill, page 3, strike lines 8 through 10 and substitute:

2 "PURSUANT TO THIS SECTION SHALL COMPLETE THE TRAINING AND  
3 CURRICULA DEVELOPED BY THE HUMAN TRAFFICKING COUNCIL CREATED  
4 IN SECTION 18-3-505 FOR PERSONS WHO WORK IN OR WHO FREQUENT  
5 PLACES WHERE HUMAN TRAFFICKING VICTIMS ARE LIKELY TO APPEAR. THE  
6 TRAINING AND CURRICULA MUST BE COMPLETED PRIOR TO PERMITTING  
7 PARTIES TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN  
8 REQUIREMENTS WITHOUT APPEARING IN PERSON PURSUANT TO THIS  
9 SECTION; EXCEPT THAT IF A COUNTY CLERK AND RECORDER PERMITS THE  
10 PARTIES TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN REQUIREMENTS  
11 WITHOUT APPEARING IN PERSON ON AND BEFORE THE  
12 EFFECTIVE DATE OF HB 21-1287, THE TRAINING AND CURRICULA MUST BE  
13 COMPLETED NO LATER THAN THIRTY DAYS AFTER THE EFFECTIVE DATE OF  
14 HB 21-1287. A COUNTY CLERK AND RECORDER WHO PERMITS THE PARTIES  
15 TO A PROSPECTIVE MARRIAGE TO SATISFY CERTAIN REQUIREMENTS  
16 WITHOUT APPEARING IN PERSON SHALL MAINTAIN RECORDS  
17 DEMONSTRATING COMPLIANCE WITH THIS SUBSECTION (3) AND SHALL  
18 DISPLAY A NOTICE OF COMPLIANCE WITH THIS SUBSECTION (3) IN A PLACE  
19 THAT IS ACCESSIBLE TO THE PUBLIC IN THE COUNTY CLERK AND  
20 RECORDER'S OFFICE AND ON ITS WEBSITE.".

21 Page 4, strike lines 11 through 13 and substitute:

22 "PURSUANT TO THIS SECTION SHALL COMPLETE THE TRAINING AND  
23 CURRICULA DEVELOPED BY THE HUMAN TRAFFICKING COUNCIL CREATED  
24 IN SECTION 18-3-505 FOR PERSONS WHO WORK IN OR WHO FREQUENT  
25 PLACES WHERE HUMAN TRAFFICKING VICTIMS ARE LIKELY TO APPEAR. THE  
26 TRAINING AND CURRICULA MUST BE COMPLETED PRIOR TO PERMITTING  
27 PARTIES TO A PROPOSED CIVIL UNION TO SATISFY CERTAIN REQUIREMENTS  
28 WITHOUT APPEARING IN PERSON PURSUANT TO THIS SECTION; EXCEPT THAT  
29 IF A COUNTY CLERK AND RECORDER PERMITS THE PARTIES TO A PROPOSED  
30 CIVIL UNION TO SATISFY CERTAIN REQUIREMENTS WITHOUT APPEARING IN  
31 PERSON ON AND BEFORE THE EFFECTIVE DATE OF HB 21-1287, THE  
32 TRAINING AND CURRICULA MUST BE COMPLETED NO LATER THAN THIRTY  
33 DAYS AFTER THE EFFECTIVE DATE OF HB 21-1287. A COUNTY CLERK AND  
34 RECORDER WHO PERMITS THE PARTIES TO A PROPOSED CIVIL UNION TO  
35 SATISFY CERTAIN REQUIREMENTS WITHOUT APPEARING IN PERSON SHALL  
36 MAINTAIN RECORDS DEMONSTRATING COMPLIANCE WITH THIS SUBSECTION  
37 (3) AND SHALL DISPLAY A NOTICE OF COMPLIANCE WITH THIS SUBSECTION  
38 (3) IN A PLACE THAT IS ACCESSIBLE TO THE PUBLIC IN THE COUNTY CLERK  
39 AND RECORDER'S OFFICE AND ON ITS WEBSITE.".
