1 Amend Health & Human Services Committee Report, dated March 24,  
2 2021, page 1, strike lines 11 through 21.

3 Page 2 of the committee report, strike lines 1 and 2 and substitute:

4 "Page 4, strike lines 10 through 24 and substitute:

5         "(b) "FAMILY-PLANNING-RELATED SERVICES" MEANS SERVICES  
6 PROVIDED IN A FAMILY PLANNING SETTING AS PART OF OR AS A FOLLOW-UP  
7 TO A FAMILY PLANNING VISIT, INCLUDING:

8             (I) MEDICALLY NECESSARY EVALUATIONS OR PREVENTIVE  
9 SERVICES, SUCH AS TOBACCO UTILIZATION SCREENING, COUNSELING,  
10 TESTING, AND CESSATION SERVICES;

11             (II) CERVICAL CANCER SCREENING AND PREVENTION;

12             (III) DIAGNOSIS OR TREATMENT OF A SEXUALLY TRANSMITTED  
13 INFECTION OR SEXUALLY TRANSMITTED DISEASE AND MEDICATION AND  
14 SUPPLIES TO PREVENT A SEXUALLY TRANSMITTED INFECTION OR SEXUALLY  
15 TRANSMITTED DISEASE; AND

16             (IV) ANY OTHER MEDICAL DIAGNOSIS, TREATMENT, OR  
17 PREVENTIVE SERVICE THAT IS ROUTINELY PROVIDED PURSUANT TO A  
18 FAMILY PLANNING VISIT.

19         (c) "FAMILY PLANNING SERVICES" MEANS ALL SERVICES COVERED  
20 BY THE FEDERAL TITLE X FAMILY PLANNING PROGRAM, REGARDLESS OF  
21 AN INDIVIDUAL'S AGE, SEX, OR GENDER IDENTITY, OR THE AGE, SEX, OR  
22 GENDER IDENTITY OF THE INDIVIDUAL'S PARTNER, INCLUDING BUT NOT  
23 LIMITED TO:

24             (I) ALL CONTRACEPTION, AS DEFINED IN SECTION 2-4-401 (1.5);  
25             (II) HEALTH-CARE AND COUNSELING SERVICES FOCUSED ON  
26 PREVENTING, DELAYING, OR PLANNING FOR A PREGNANCY;

27             (III) FOLLOW-UP VISITS TO EVALUATE OR MANAGE PROBLEMS  
28 ASSOCIATED WITH CONTRACEPTIVE METHODS;

29             (IV) STERILIZATION SERVICES, REGARDLESS OF AN INDIVIDUAL'S  
30 SEX; AND

31             (V) BASIC FERTILITY SERVICES.".
