SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor, & Technology.

SB21-134 be amended as follows:

1 Amend printed bill, page 3, strike lines 1 and 2 and substitute "SECTION
2 44-3-409 (1)(a.5) INCLUDES, AS APPLICABLE, A TRANSFER OF OWNERSHIP
3 OF MULTIPLE RETAIL LIQUOR STORES, A CHANGE OF LOCATION OF ALL
4 BUT".

5 Page 5, line 8, strike "(1) (d) (I)" and substitute "(1) (a.5) (I)".

6 Page 5, line 9, strike "(1)(d)," and substitute "(1)(a.5), EXCEPT AS
7 PROVIDED IN SUBSECTION (1)(a.5)(II) OF THIS SECTION,".

8 Page 5, line 11, strike "THE" and substitute "A".

9 Page 6, after line 21 insert:

10 "(II) IF THE APPLICANT FOR AN ADDITIONAL RETAIL LIQUOR STORE
11 LICENSE UNDER SUBSECTION (4)(b)(III.5) OF THIS SECTION IS A RETAIL
12 LIQUOR STORE LICENSEE WHOSE LICENSED PREMISES IS NOT LARGER THAN
13 TEN THOUSAND SQUARE FEET, THE APPLICANT MAY APPLY TO TRANSFER
14 OWNERSHIP OF A RETAIL LIQUOR STORE THAT WAS LICENSED BEFORE
15 JANUARY 1, 2021, AND FOR WHICH THE LICENSED PREMISES IS NOT LARGER
16 THAN TEN THOUSAND SQUARE FEET, REGARDLESS OF WHETHER THE RETAIL
17 LIQUOR STORE PREMISES THAT IS THE SUBJECT OF THE TRANSFER OF
18 OWNERSHIP APPLICATION SATISFIES THE DISTANCE REQUIREMENTS
19 SPECIFIED IN SUBSECTION (1)(a)(II) OF THIS SECTION. AN APPLICANT
20 UNDER THIS SUBSECTION (1)(a.5)(II) MUST NOT INCREASE THE SQUARE
21 FOOTAGE OR CHANGE THE LOCATION OF THE PREMISES OF THE RETAIL
22 LIQUOR STORE THAT IS THE SUBJECT OF THE TRANSFER OF OWNERSHIP
23 APPLICATION, AS THE PREMISES EXISTED AT THE TIME OF THE
24 APPLICATION, FOR AT LEAST FIVE YEARS AFTER THE DATE OF THE
25 APPLICATION."

26 Renumber succeeding subparagraphs accordingly.

27 Page 6, line 23, strike "(1)(d)(I)(B)" and substitute "(1)(a.5)(I)(B)".

28 Page 7, line 2, strike "THE TRANSFER OF" and substitute "AN APPLICATION
29 UNDER THIS SUBSECTION (1)(a.5),".

30 Page 7, strike line 3.

31 Page 8, line 24, strike "SECTION" and substitute "SECTION, EXCEPT AS

1 PROVIDED IN SUBSECTION (1)(a.5)(II) OF THIS SECTION,".

2 Strike "(1)(d)" and substitute "(1)(a.5)" on: **Page 3**, line 14; **Page 4**, lines
3 7 and 27; **Page 5**, line 6; **Page 8**, line 26; and **Page 10**, lines 14 and 23.
