

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB24-1296 be amended as follows:

- 1 Amend printed bill, page 8, line 9, strike "(f)" and substitute "(e)".
- 2 Page 8, line 12, strike "TWO-DAY".
- 3 Page 8, strike line 13 and substitute " THREE-DAY OR FIVE-DAY PERIOD, AS
4 APPLICABLE, AND,".
- 5 Page 8, line 14, strike "SUBSECTIONS (3)(b) AND (3)(d)" and substitute
6 "SUBSECTION (3)(b)".
- 7 Page 8, line 17, after the period add "A REQUESTER MAY SUBMIT WITH A
8 REQUEST A SIGNED STATEMENT AFFIRMING THAT THE REQUESTED PUBLIC
9 RECORDS WILL NOT BE USED FOR THE DIRECT SOLICITATION OF BUSINESS
10 FOR PECUNIARY GAIN, WHICH THE CUSTODIAN MUST CONSIDER IN MAKING
11 THE CUSTODIAN'S DETERMINATION PURSUANT TO THIS SUBSECTION
12 (3)(e)(I).".
- 13 Page 8, strike lines 20 through 25 and substitute "BUSINESS FOR
14 PECUNIARY GAIN MAY APPLY TO THE DISTRICT COURT OF THE DISTRICT IN
15 WHICH THE REQUESTED PUBLIC RECORDS ARE LOCATED FOR A
16 DETERMINATION THAT THE REQUEST IS NOT FOR THE DIRECT SOLICITATION
17 OF BUSINESS FOR PECUNIARY GAIN. THE COURT SHALL REVIEW THE
18 MATTER AT THE EARLIEST PRACTICAL TIME AND HAS DISCRETION TO LIMIT
19 ITS REVIEW TO SUBMISSION OF PLEADINGS, AFFIDAVITS, AND OTHER
20 MATERIAL AS DEEMED APPROPRIATE BY THE COURT, OR THE COURT MAY
21 SCHEDULE A HEARING. IN ITS REVIEW, THE COURT SHALL APPLY AN ABUSE
22 OF DISCRETION STANDARD TO THE CUSTODIAN'S DETERMINATION.".
- 23 Page 9, after line 3 insert:
 - 24 " (IV) A REQUEST FOR PUBLIC RECORDS FOR PURPOSES RELATED TO
25 COLLECTIVE BARGAINING, ORGANIZING, OR OTHER RIGHTS AND ACTIVITIES
26 PROTECTED BY ARTICLE 33 OF TITLE 29 BY AN ENTITY ENGAGED IN
27 COLLECTIVE BARGAINING, ORGANIZING, OR OTHER RIGHTS AND ACTIVITIES
28 PROTECTED BY ARTICLE 33 OF TITLE 29 IS NOT A REQUEST FOR THE DIRECT
29 SOLICITATION OF BUSINESS FOR PECUNIARY GAIN.
 - 30 (V) THIS SUBSECTION (3)(f) DOES NOT APPLY TO A CONTRACT OR
31 OTHER INFORMATION DELIVERED ROUTINELY USING COMPUTER DATA
32 EXTRACTION METHODS THAT REQUIRE MINIMAL HUMAN INTERVENTION
33 FOR RETRIEVAL.".
