

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB21-053 be amended as follows:

1 Amend printed bill, page 4, line 26, after "DISTRICTS" insert "AND TO THE
2 STATE CHARTER SCHOOL INSTITUTE".

3 Page 4, strike line 27 and substitute "SUBSECTIONS (3) AND (6) OF THIS
4 SECTION.".

5 Page 5, strike lines 25 through 27.

6 Page 6, strike lines 1 and 2 and substitute:

7 "(5) EACH DISTRICT THAT AUTHORIZES A CHARTER SCHOOL SHALL
8 DISTRIBUTE TO THE CHARTER SCHOOL ONE HUNDRED PERCENT OF THE
9 DISTRICT CHARTER SCHOOL'S PER-PUPIL SHARE OF THE DISTRIBUTION
10 RECEIVED BY THE DISTRICT PURSUANT TO THIS SECTION. A DISTRICT
11 CHARTER SCHOOL'S DISTRIBUTION IS DETERMINED BY DIVIDING THE
12 AMOUNT OF THE DISTRIBUTION RECEIVED BY THE DISTRICT PURSUANT TO
13 THIS SECTION BY THE DISTRICT'S FUNDED PUPIL COUNT FOR THE 2020-21
14 BUDGET YEAR AND THEN MULTIPLYING THAT AMOUNT BY THE DISTRICT
15 CHARTER SCHOOL'S PUPIL ENROLLMENT FOR THE 2020-21 BUDGET YEAR.

16 "(6) FOR EACH INSTITUTE CHARTER SCHOOL LOCATED WITHIN AN
17 ACCOUNTING DISTRICT THAT RECEIVES A DISTRIBUTION PURSUANT TO THIS
18 SECTION, THE DEPARTMENT SHALL CALCULATE A DISTRIBUTION AMOUNT
19 FOR THE INSTITUTE CHARTER SCHOOL. THE DEPARTMENT SHALL
20 CALCULATE AN INSTITUTE CHARTER SCHOOL'S DISTRIBUTION BY DIVIDING
21 THE AMOUNT OF THE DISTRIBUTION RECEIVED BY THE ACCOUNTING
22 DISTRICT PURSUANT TO THIS SECTION BY THE ACCOUNTING DISTRICT'S
23 FUNDED PUPIL COUNT FOR THE 2020-21 BUDGET YEAR AND THEN
24 MULTIPLYING THAT AMOUNT BY THE INSTITUTE CHARTER SCHOOL'S PUPIL
25 ENROLLMENT FOR THE 2020-21 BUDGET YEAR. THE DISTRIBUTION FOR AN
26 INSTITUTE CHARTER SCHOOL IS SEPARATE FROM AND DOES NOT AFFECT
27 THE AMOUNT OF THE DISTRIBUTION TO THE INSTITUTE CHARTER SCHOOL'S
28 ACCOUNTING DISTRICT. THE DEPARTMENT SHALL DISTRIBUTE THE TOTAL
29 AMOUNT CALCULATED PURSUANT TO THIS SUBSECTION (6) TO THE STATE
30 CHARTER SCHOOL INSTITUTE, WHICH SHALL DISTRIBUTE TO EACH
31 INSTITUTE CHARTER SCHOOL ONE HUNDRED PERCENT OF THE AMOUNT
32 CALCULATED FOR THE INSTITUTE CHARTER SCHOOL PURSUANT TO THIS
33 SUBSECTION (6).".
