17 REPRESENTATIVES AND THE HEALTH AND HUMAN SERVICES COMMITTEE OF  
18 THE SENATE, OR ANY SUCCESSOR COMMITTEE, CONCERNING:
    - 19 (a) THE LEGALITY, OBSTACLES, AND BENEFITS OF SETTING UPPER  
20 PAYMENT LIMITS ON ALL PURCHASES AND PAYER REIMBURSEMENTS OF  
21 PRESCRIPTION DRUG PRODUCTS IN THE STATE; AND
    - 22 (b) RECOMMENDATIONS REGARDING WHETHER THE GENERAL  
23 ASSEMBLY SHOULD PASS LEGISLATION TO EXPAND THE AUTHORITY OF THE  
24 BOARD TO SET UPPER PAYMENT LIMITS ON ALL PURCHASES AND PAYER  
25 REIMBURSEMENTS OF PRESCRIPTION DRUG PRODUCTS IN THE STATE.
  - 26 (2) THE FAILURE OF AN ENTITY TO PROVIDE INFORMATION TO THE  
27 BOARD PURSUANT TO SECTION 10-16-1306 (7)(b) DOES NOT AFFECT THE  
28 AUTHORITY OF THE BOARD TO CONDUCT AN AFFORDABILITY REVIEW OF  
29 THE PRESCRIPTION DRUG.".

  - 8 AUTHORIZED TO ENFORCE THIS".
- 9 Renumber succeeding C.R.S. sections accordingly.
- 10 Page 28, strike lines 3 through 22.
- 11 Renumber succeeding C.R.S. sections accordingly.
- 12 Page 29, strike lines 17 through 22.
- 13 Reletter succeeding paragraphs accordingly.
