1 Amend reengrossed bill, page 2, after line 1 insert:

2       **"SECTION 1.** In Colorado Revised Statutes, **add** 24-75-226 as  
3 follows:

4       **24-75-226. Cash fund transfers - repeal.** (1) TO REPAY CASH  
5 FUNDS FROM WHICH THE STATE TREASURER WAS REQUIRED TO TRANSFER  
6 MONEY TO THE GENERAL FUND UNDER HOUSE BILL 20-1406, ENACTED IN  
7 2020, ON JULY 1, 2021, THE STATE TREASURER SHALL TRANSFER THE  
8 FOLLOWING AMOUNTS FROM THE GENERAL FUND:

9           (a) \$6,000,000 TO THE PETROLEUM CLEAN UP AND  
10 REDEVELOPMENT FUND;

11           (b) \$1,000,000 TO THE WORKERS' COMPENSATION CASH FUND;

12           (c) \$2,000,000 TO THE UNEMPLOYMENT REVENUE FUND;

13           (d) \$500,000 TO THE CONVEYANCE SAFETY FUND;

14           (e) \$1,224,100 TO THE DIVISION OF INSURANCE CASH FUND;

15           (f) \$370,795 TO THE DIVISION OF BANKING CASH FUND;

16           (g) \$267,521 TO THE PRESCRIPTION DRUG MONITORING FUND;

17           (h) \$1,000,000 TO THE SCHOOL SAFETY RESOURCE CENTER CASH  
18 FUND;

19           (i) \$130,000 TO THE STATE ARCHIVES AND RECORDS CASH FUND;

20           (j) \$180,000 TO THE VITAL STATISTICS RECORDS CASH FUND;

21           (k) \$433,728 TO THE CONSTRUCTION SECTOR FUND;

22           (l) \$500,000 TO THE PUBLIC AND PRIVATE UTILITIES SECTOR FUND;

23           (m) \$483,535 TO THE WATER QUALITY IMPROVEMENT FUND;

24           (n) \$422,411 TO THE HAZARDOUS WASTE SERVICE FUND;

25           (o) \$498,395 TO THE ACCOUNT SPECIFIED IN SECTION 28-3-106  
26 (1)(s)(I);

27           (p) \$363,243 TO THE SOLID WASTE MANAGEMENT FUND;

28           (q) \$5,372,415 TO THE WASTE TIRE ADMINISTRATION,  
29 ENFORCEMENT, MARKET DEVELOPMENT, AND CLEANUP FUND;

30           (r) \$1,400,000 TO THE END USERS FUND;

31           (s) \$2,300,000 TO THE LOCAL GOVERNMENT PERMANENT FUND;

32           (t) \$1,700,176 TO THE HIGHWAY-RAIL CROSSING SIGNALIZATION  
33 FUND; AND

34           (u) \$1,600,000 TO THE MARIJUANA CASH FUND.

35           (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2022.".
