1 Amend reengrossed bill, page 2, after line 1 insert:

2 **"SECTION 1.** In Colorado Revised Statutes, 24-75-302, **amend**
3 (3.3)(b) as follows:

4 **24-75-302. Capital construction fund - capital assessment fees**
5 **- calculation - information technology capital account.**
6 (3.3) (b) Notwithstanding subsection (3.3)(a) of this section, on June 30,
7 2020, the state treasurer shall transfer seven million nine hundred
8 thousand dollars from the Fort Logan land sale account to the general
9 fund. **ON JULY 1, 2021, THE STATE TREASURER SHALL TRANSFER SEVEN**
10 **MILLION NINE HUNDRED THOUSAND DOLLARS FROM THE GENERAL FUND TO**
11 **THE FORT LOGAN LAND SALE ACCOUNT.**

12 **SECTION 2.** In Colorado Revised Statutes, 28-3-106, **amend**
13 (1)(s)(III) as follows:

14 **28-3-106. Powers and duties of adjutant general.** (1) The
15 adjutant general has the following powers and duties:

16 (s) (III) Notwithstanding subsection (1)(s)(I) of this section, on
17 July 1, 2020, the state treasurer shall transfer four million nine hundred
18 eight thousand three hundred ninety-five dollars from the account
19 specified in subsection (1)(s)(I) of this section to the general fund. **THE**
20 **STATE TREASURER SHALL TRANSFER FOUR MILLION NINE HUNDRED EIGHT**
21 **THOUSAND THREE HUNDRED NINETY-FIVE DOLLARS FROM THE GENERAL**
22 **FUND TO THE ACCOUNT SPECIFIED IN SUBSECTION (1)(S)(I) OF THIS**
23 **SECTION.**

24 **SECTION 3.** In Colorado Revised Statutes, 28-5-709, **amend**
25 (1)(c)(II) as follows:

26 **28-5-709. Colorado state veterans trust fund - created - report.**
27 (1) (c) (II) On July 1, 2020, the state treasurer shall transfer three million
28 dollars from the trust fund to the general fund. **ON JULY 1, 2021, THE**
29 **STATE TREASURER SHALL TRANSFER THREE MILLION DOLLARS FROM THE**
30 **GENERAL FUND TO THE TRUST FUND.**".

31 **SECTION 4.** In Colorado Revised Statutes, 28-5-712, **amend**
32 (3)(e) as follows:

33 **28-5-712. Veterans assistance grant program - created - rules**
34 **- fund - repeal.** (3) (e) Notwithstanding subsection (2)(b) of this section,
35 on June 30, 2020, the state treasurer shall transfer one million dollars
36 from the fund to the general fund. **ON JULY 1, 2021, THE STATE**
37 **TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE GENERAL**
38 **FUND TO THE FUND.**".
