

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Education.

SB21-185 be amended as follows:

1 Amend reengrossed bill, page 30, after line 25 insert:

2       **"SECTION 24.** In Colorado Revised Statutes, **add** 23-20-141 as  
3 follows:

4       **23-20-141. Educator well-being and mental health program -**  
5 **reporting - repeal.** (1) THE UNIVERSITY OF COLORADO HEALTH SCIENCES  
6 CENTER SHALL ESTABLISH AND OPERATE AN EDUCATOR WELL-BEING AND  
7 MENTAL HEALTH PROGRAM TO PROVIDE SUPPORT SERVICES FOR  
8 EDUCATORS SERVING STUDENTS IN COLORADO'S PUBLIC ELEMENTARY AND  
9 SECONDARY SCHOOLS.

10       (2) THE SERVICES PROVIDED THROUGH THE EDUCATOR  
11 WELL-BEING AND MENTAL HEALTH PROGRAM MUST INCLUDE, BUT ARE NOT  
12 LIMITED TO:

13       (a) A HOTLINE SERVICE FOR EDUCATORS, PROVIDING DAILY  
14 TELEPHONE AND TEXT ACCESS;

15       (b) STAFFED SUPPORT GROUPS; AND

16       (c) TRAINING AND SUPPORT PROGRAMS FOR EDUCATORS THAT  
17 FOCUS ON COPING WITH STRESS AND BUILDING RESILIENCE DURING THE  
18 COVID-19 PANDEMIC AND RECOVERY FROM THE PANDEMIC.

19       (3) THE DEPARTMENT OF HIGHER EDUCATION SHALL ENTER INTO  
20 A LIMITED PURPOSE FEE-FOR-SERVICE CONTRACT WITH THE UNIVERSITY OF  
21 COLORADO HEALTH SCIENCES CENTER PURSUANT TO SECTION 23-18-308  
22 TO PROVIDE STATE FUNDING FOR THE EDUCATOR WELL-BEING AND  
23 MENTAL HEALTH PROGRAM TO SUPPLEMENT OTHER SOURCES OF FUNDING.

24       (4) ON OR BEFORE NOVEMBER 1, 2022, AND ON OR BEFORE  
25 NOVEMBER 1 EACH YEAR THEREAFTER, THE UNIVERSITY OF COLORADO  
26 HEALTH SCIENCES CENTER SHALL SUBMIT A REPORT TO THE DEPARTMENT  
27 OF HIGHER EDUCATION CONCERNING THE USE OF STATE FUNDING FOR THE  
28 EDUCATOR WELL-BEING AND MENTAL HEALTH PROGRAM, INCLUDING  
29 INFORMATION ABOUT THE NUMBER OF EDUCATORS SERVED, THE SERVICES  
30 PROVIDED, FUNDING RECEIVED FROM OTHER SOURCES, AND OTHER  
31 RELEVANT DATA AND INFORMATION ABOUT THE IMPLEMENTATION OF THE  
32 PROGRAM AND PROGRAM OUTCOMES.

33       (5) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2026.

34       **SECTION 25.** In Colorado Revised Statutes, 23-18-308, **add**  
35 (1)(h) as follows:

36       **23-18-308. Fee-for-service contracts - limited purpose - repeal.**

37       (1) Subject to available appropriations, the department shall enter into  
38 fee-for-service contracts for the following purposes:

39       (h) (I) THE EDUCATOR WELL-BEING AND MENTAL HEALTH  
40 PROGRAM PURSUANT TO SECTION 23-20-141.

41       (II) THIS SUBSECTION (1)(h) IS REPEALED, EFFECTIVE JULY 1, 2026.

1           **SECTION 26.** In Colorado Revised Statutes, 23-3.3-103, **add (9)**  
2 as follows:

3           **23-3.3-103. Annual appropriations - repeal.** (9) (a) THE  
4 PROVISIONS OF SUBSECTION (1) OF THIS SECTION CONCERNING  
5 APPROPRIATIONS FOR STUDENT FINANCIAL ASSISTANCE UNDER THIS  
6 ARTICLE 3.3 DO NOT APPLY TO APPROPRIATIONS MADE PURSUANT TO  
7 SECTIONS 23-18-308 (1)(h) AND 23-20-141 FOR THE EDUCATOR  
8 WELL-BEING AND MENTAL HEALTH PROGRAM.

9           (b) THIS SUBSECTION (9) IS REPEALED, EFFECTIVE JULY 1, 2026.".
