

HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Education.

SB21-116 be amended as follows:

- 1 Amend reengrossed bill, page 4, after line 18 insert:
 - 2 "(b) "COMMISSION" MEANS THE COLORADO COMMISSION OF
 - 3 INDIAN AFFAIRS, ESTABLISHED PURSUANT TO SECTION 24-44-102.".
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 6, after line 17 insert:
 - 6 "(4) (a) NO LATER THAN 30 DAYS AFTER THE EFFECTIVE DATE OF
 - 7 THIS SECTION, THE COMMISSION SHALL IDENTIFY EACH PUBLIC SCHOOL IN
 - 8 THE STATE THAT IS USING AN AMERICAN INDIAN MASCOT AND THAT DOES
 - 9 NOT MEET THE CRITERIA FOR AN EXEMPTION AS OUTLINED IN SUBSECTION
 - 10 (2)(b) OF THIS SECTION. THE COMMISSION SHALL POST SUCH INFORMATION
 - 11 ON ITS WEBSITE.
- 12 (b) IN ADDITION TO POSTING ON ITS WEBSITE THE INFORMATION
- 13 CONCERNING PUBLIC SCHOOLS THAT ARE USING AN AMERICAN INDIAN
- 14 MASCOT, THE COMMISSION, IN COORDINATION WITH THE DEPARTMENT OF
- 15 EDUCATION, SHALL NOTIFY THE SCHOOL DISTRICT OF A PUBLIC SCHOOL
- 16 IDENTIFIED BY THE COMMISSION PURSUANT TO SUBSECTION (4)(a) OF THIS
- 17 SECTION OF THE REQUIREMENTS RELATED TO THE USE OF AMERICAN
- 18 INDIAN MASCOTS, AS SET FORTH IN SUBSECTION (2) OF THIS SECTION, AS
- 19 WELL AS THE PENALTY FOR CONTINUED USED OF SUCH MASCOTS AS
- 20 OUTLINED IN SUBSECTION (3) OF THIS SECTION. THE COMMISSION, IN
- 21 COORDINATION WITH THE DEPARTMENT OF EDUCATION, SHALL ALSO
- 22 PROVIDE THE SAME NOTIFICATION TO THE CHARTER SCHOOL INSTITUTE IF
- 23 ANY INSTITUTE SCHOOLS ARE IDENTIFIED PURSUANT TO SUBSECTION (4)(a)
- 24 OF THIS SECTION.

- 25 (c) WHEN A PUBLIC SCHOOL IDENTIFIED PURSUANT TO SUBSECTION
- 26 (4)(a) OF THIS SECTION DISCONTINUES ITS USE OF ITS AMERICAN INDIAN
- 27 MASCOT PRIOR TO JUNE 1, 2022, THE PUBLIC SCHOOL SHALL NOTIFY ITS
- 28 SCHOOL DISTRICT, OR, IN THE CASE OF AN INSTITUTE CHARTER SCHOOL, ITS
- 29 AUTHORIZER, THE COMMISSION, AND THE DEPARTMENT OF EDUCATION OF
- 30 SUCH DISCONTINUATION.".
