19 MONEY THAT IS CREDITED TO THE HIGHWAY USERS TAX FUND AS
20 REQUIRED BY SECTIONS 24-38.5-304 (2), 25-7.5-104 (2), 43-4-1204 (2),
21 AND 43-4-1304 (2)".
