5 ENDS BEFORE THE STATE FISCAL YEAR FOR WHICH THE FEE IS TO BE  
6 IMPOSED BEGINS OR:".

30 ADMINISTRATION FOR THE CALENDAR YEAR THAT ENDS BEFORE THE STATE  
31 FISCAL YEAR FOR WHICH THE FEE IS TO BE IMPOSED BEGINS OR".
