

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB21-252 be amended as follows:

1 Amend reengrossed bill, page 8, after line 16 insert:

2 **"SECTION 3.** In Colorado Revised Statutes, 24-32-129, **amend**
3 (3) as follows:

4 **24-32-129. Small business relief program - address negative**
5 **effects of capacity limits due to COVID-19 pandemic - distribution**
6 **through local governments - definitions - report - repeal.**
7 (3) **Funding.** (a) For the 2020-21 state fiscal year, the general assembly
8 shall appropriate thirty-seven million dollars from the general fund to the
9 department of local affairs for use by the division in accordance with this
10 section.

11 (b) THE DEPARTMENT OF LOCAL AFFAIRS SHALL NOTIFY THE STATE
12 TREASURER IF, ON JUNE 30, 2021, THERE IS UNEXPENDED AND
13 UNENCUMBERED MONEY REMAINING FROM THE AMOUNT APPROPRIATED
14 TO THE DEPARTMENT PURSUANT TO THIS SUBSECTION (3). IF THE STATE
15 TREASURER IS SO NOTIFIED, THE STATE TREASURER SHALL TRANSFER
16 SEVEN MILLION DOLLARS OF THE UNEXPENDED AND UNENCUMBERED
17 AMOUNT TO THE DEPARTMENT FOR USE BY THE DIVISION OF LOCAL
18 GOVERNMENT IN ADMINISTERING THE COLORADO MAIN STREET PROGRAM.
19 NOT MORE THAN FOUR PERCENT OF THE MONEY APPROPRIATED TO THE
20 DIVISION FOR PURPOSES OF THIS SECTION MAY BE USED TO COVER THE
21 TOTAL ADMINISTRATIVE COSTS OF THE DIVISION IN ADMINISTERING THE
22 PROGRAM.

23 **SECTION 4.** In Session Laws of Colorado 2020, First
24 Extraordinary Session of the Seventy-Second General Assembly, section
25 10 of chapter 2, **amend** (1) as follows:

26 Section 10. **Appropriation.** (1) For the 2020-21 state fiscal year,
27 ~~\$37,000,000~~ **\$30,000,000** is appropriated to the department of local
28 affairs for use by the division of local government. This appropriation is
29 from the general fund and is based on an assumption that the department
30 will require an additional 2.1 FTE. To implement this act, the division
31 may use this appropriation for relief to small businesses.

32 **SECTION 5. Appropriation.** For the 2021-22 state fiscal year,
33 \$7,000,000 is appropriated to the department of local affairs for use by
34 the division of local government. This appropriation is from the general
35 fund. To implement this act, the division may use the appropriation for
36 Colorado main street program.".
