

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB24-067 be amended as follows:

- 1 Amend printed bill, page 6, line 10, after the period add "If THE
- 2 HEALTH-RELATED RESEARCH FACILITY HAS AN INTERNAL ADOPTION
- 3 PROGRAM, THE FACILITY MAY FIRST OFFER THE DOG OR CAT FOR ADOPTION
- 4 THROUGH THE INTERNAL ADOPTION PROGRAM BEFORE OFFERING THE DOG
- 5 OR CAT TO AN ANIMAL SHELTER OR PET ANIMAL RESCUE.
- 6 HEALTH-RELATED RESEARCH FACILITIES WITH INTERNAL ADOPTION
- 7 PROGRAMS SHALL NOT REPORT ANY PERSONALLY IDENTIFYING
- 8 INFORMATION ABOUT INDIVIDUAL INTERNAL ADOPTERS."
- 9 Page 6, line 13, strike "HEALTH" and substitute "RESEARCH, HEALTH,".
- 10 Page 6, line 18, before "TRANSFER" insert "ADOPT OUT A DOG OR CAT
- 11 THROUGH AN INTERNAL ADOPTION PROGRAM OR TO".
- 12 Page 6, strike lines 22 through 27.
- 13 Page 7, strike lines 1 through 7 and substitute:
  - 14 "(4) AT THE SAME TIME THAT A HEALTH-RELATED RESEARCH
  - 15 FACILITY SUBMITS ITS ANNUAL REPORT TO THE UNITED STATES
  - 16 DEPARTMENT OF AGRICULTURE, THE HEALTH-RELATED RESEARCH
  - 17 FACILITY SHALL SUBMIT TO THE DEPARTMENT A REPORT THAT INCLUDES
  - 18 THE FOLLOWING INFORMATION FOR THE PREVIOUS CALENDAR YEAR:
  - 19 (a) THE TOTAL NUMBER OF DOGS AND CATS THAT THE
  - 20 HEALTH-RELATED RESEARCH FACILITY:
    - 21 (I) ADOPTED OUT THROUGH AN INTERNAL ADOPTION PROGRAM; OR
    - 22 (II) TRANSFERRED TO AN ANIMAL SHELTER OR PET ANIMAL RESCUE
    - 23 FOR THE PURPOSE OF ADOPTION; AND".
- 24 Page 7, line 8, strike "(d)" and substitute "(b)".
