

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 13, strike lines 2 through 5 and substitute  
2 **"service providers - rules.** (1) (a) AN EMPLOYER SHALL NOT INTERFERE  
3 WITH AN AGRICULTURAL WORKER'S REASONABLE ACCESS TO VISITORS AT  
4 THE AGRICULTURAL WORKER'S EMPLOYER-PROVIDED HOUSING DURING  
5 ANY TIME WHEN THE AGRICULTURAL WORKER IS PRESENT AT SUCH  
6 HOUSING.

7 (b) AN EMPLOYER SHALL NOT INTERFERE WITH AN AGRICULTURAL  
8 EMPLOYEE'S REASONABLE ACCESS TO KEY SERVICE PROVIDERS AT ANY  
9 LOCATION DURING ANY TIME IN WHICH THE AGRICULTURAL WORKER IS  
10 NOT PERFORMING COMPENSABLE WORK OR DURING PAID OR UNPAID REST  
11 AND MEAL BREAKS, AND WITH RESPECT TO HEALTH-CARE PROVIDERS  
12 DURING ANY TIME, WHETHER OR NOT THE AGRICULTURAL WORKER IS  
13 WORKING.

14 (c) TO ENSURE THAT AGRICULTURAL EMPLOYEES HAVE  
15 MEANINGFUL ACCESS TO SERVICES, THE DIRECTOR OF THE DIVISION SHALL  
16 PROMULGATE RULES REGARDING ADDITIONAL TIMES DURING WHICH AN  
17 EMPLOYER MAY NOT INTERFERE WITH AN AGRICULTURAL WORKER'S  
18 REASONABLE ACCESS TO KEY SERVICE PROVIDERS, INCLUDING PERIODS  
19 DURING WHICH THE AGRICULTURAL WORKER IS PERFORMING  
20 COMPENSABLE WORK, ESPECIALLY DURING PERIODS WHEN THE  
21 AGRICULTURAL WORKER IS REQUIRED TO WORK IN EXCESS OF FORTY  
22 HOURS PER WEEK AND MAY HAVE DIFFICULTY ACCESSING SUCH SERVICES  
23 OUTSIDE OF WORK HOURS. THE RULES MUST BE PROPOSED ON OR BEFORE  
24 OCTOBER 31, 2021, AND ADOPTED ON OR BEFORE JANUARY 31, 2022.

25 (d) AN EMPLOYER MAY REQUIRE VISITORS ACCESSING A WORK SITE  
26 TO FOLLOW PROTOCOLS DESIGNED TO MANAGE BIOHAZARDS AND OTHER  
27 RISKS OF CONTAMINATION, TO PROMOTE FOOD SAFETY, AND TO REDUCE  
28 THE RISK OF INJURIES TO OR FROM LIVESTOCK ON FARMS AND RANCHES  
29 EXCEPT ON THE OPEN RANGE, IF THE SAME PROTOCOLS ARE GENERALLY  
30 APPLIED TO ANY OTHER THIRD PARTIES WHO MAY HAVE OCCASION TO  
31 ENTER THE WORK SITE.".
