

HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Education.

HB24-1164 be amended as follows:

1 Amend printed bill, page 4, strike line 14 and substitute:

2 "(3) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
3 CONTRARY, IF AN APPLICABLE SCHOOL BUILDING IS USED BY THE LOCAL
4 EDUCATION PROVIDER, THE COLORADO SCHOOL FOR THE DEAF AND THE
5 BLIND, OR THE APPROVED FACILITY SCHOOL TO PROVIDE EDUCATIONAL
6 SERVICES ONLY TO STUDENTS WHO ARE ENROLLED IN KINDERGARTEN
7 THROUGH GRADE SIX, THE LOCAL EDUCATION PROVIDER SHALL PROVIDE
8 MENSTRUAL PRODUCTS BUT MAY PROVIDE MENSTRUAL PRODUCTS IN A
9 HEALTH OFFICE LOCATED IN THE APPLICABLE SCHOOL BUILDING THAT IS
10 ACCESSIBLE TO STUDENTS WHO MENSTRUATE; EXCEPT THAT, IF THERE IS
11 NOT A HEALTH OFFICE, THE LOCAL EDUCATION PROVIDER SHALL PROVIDE
12 THE MENSTRUAL PRODUCTS IN AN ADMINISTRATIVE OFFICE LOCATED IN
13 THE APPLICABLE SCHOOL BUILDING ACCESSIBLE TO STUDENTS WHO
14 MENSTRUATE.

15 (4) NOTWITHSTANDING SUBSECTION (2)(a) OF THIS SECTION, IF A
16 LOCAL EDUCATION PROVIDER, THE COLORADO SCHOOL FOR THE DEAF AND
17 THE BLIND, OR AN APPROVED FACILITY SCHOOL IS EXPERIENCING
18 VANDALISM OR DESTRUCTION OF PROPERTY AS A RESULT OF COMPLYING
19 WITH THE REQUIREMENTS OF THIS SECTION, THE LOCAL EDUCATION
20 PROVIDER, THE COLORADO SCHOOL FOR THE DEAF AND THE BLIND, OR THE
21 APPROVED FACILITY SCHOOL MAY REMOVE THE MENSTRUAL PRODUCTS
22 FROM THE APPLICABLE STUDENT BATHROOM. IF A LOCAL EDUCATION
23 PROVIDER, THE COLORADO SCHOOL FOR THE DEAF AND THE BLIND, OR AN
24 APPROVED FACILITY SCHOOL REMOVES MENSTRUAL PRODUCTS FROM AN
25 APPLICABLE STUDENT BATHROOM PURSUANT TO THIS SUBSECTION (4), THE
26 LOCAL EDUCATION PROVIDER, THE COLORADO SCHOOL FOR THE DEAF AND
27 THE BLIND, OR THE APPROVED FACILITY SCHOOL SHALL POST INFORMATION
28 IN THE APPLICABLE STUDENT BATHROOM REGARDING WHERE MENSTRUAL
29 PRODUCTS ARE AVAILABLE IN THE APPLICABLE SCHOOL BUILDING.

30 (5) (a) A LOCAL EDUCATION PROVIDER THAT IS REQUIRED TO
31 COMPLY WITH SUBSECTIONS (2)(a)(I), (2)(a)(II), AND (2)(a)(III) OF THIS
32 SECTION SHALL POST INFORMATION IN APPLICABLE SCHOOL BATHROOMS
33 WHERE THERE ARE NOT YET MENSTRUAL PRODUCTS REGARDING WHERE
34 MENSTRUAL PRODUCTS ARE AVAILABLE IN THE APPLICABLE SCHOOL
35 BUILDING.

36 (b) THIS SUBSECTION (5) IS REPEALED, EFFECTIVE JULY 1, 2030.
37 (6) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE".
