

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB24-1164 be amended as follows:

1 Amend printed bill, page 5, strike line 14 and substitute "(3)(b), (3)(c),
2 and (6); and **add** (3)(d), (5.3), (5.7), (8)(d), and (8)(e) as follows:".

3 Page 5, strike lines 21 through 27.

4 Page 6, strike lines 1 through 14 and substitute:

5 "(b) The Colorado school for the deaf and the blind, created and
6 existing pursuant to section 22-80-102 (1)(a); ~~or~~

7 (c) An approved facility school, as defined in section 22-2-402
8 (1); OR

9 (d) A RURAL SCHOOL DISTRICT, A SMALL RURAL DISTRICT, A
10 CHARTER SCHOOL OF A RURAL SCHOOL DISTRICT OR A SMALL RURAL
11 DISTRICT, OR AN INSTITUTE CHARTER SCHOOL LOCATED WITHIN THE
12 GEOGRAPHIC BOUNDARIES OF A RURAL SCHOOL DISTRICT OR SMALL RURAL
13 SCHOOL DISTRICT.".

14 Page 6, strike lines 18 through 26 and substitute "SECTION.".

15 Page 6, line 27, strike "FIVE" and substitute "TEN".

16 Page 7, strike line 1 and substitute "OF THE TOTAL AMOUNT
17 APPROPRIATED PURSUANT TO SUBSECTION (5.3) OF THIS SECTION FOR THE
18 GRANT PROGRAM TO OFFSET THE".

19 Page 7, after line 18 insert:

20 "(8) As used in this section, unless the context otherwise requires:

21 (d) "RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT THAT
22 THE DEPARTMENT OF EDUCATION DETERMINES IS RURAL, BASED ON THE
23 GEOGRAPHIC SIZE OF THE SCHOOL DISTRICT AND THE DISTANCE OF THE
24 SCHOOL DISTRICT FROM THE NEAREST LARGE, URBANIZED AREA.

25 (e) "SMALL RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT
26 THAT THE DEPARTMENT OF EDUCATION DETERMINES IS RURAL, BASED ON
27 THE GEOGRAPHIC SIZE OF THE SCHOOL DISTRICT AND THE DISTANCE OF THE
28 SCHOOL DISTRICT FROM THE NEAREST LARGE, URBANIZED AREA, AND THAT
29 ENROLLS FEWER THAN ONE THOUSAND TWO HUNDRED STUDENTS IN
30 KINDERGARTEN THROUGH TWELFTH GRADE.".
