HB25-1320 be amended as follows:

1 Amend printed bill, page 5, after line 16 insert:

2 **"SECTION 2.** In Colorado Revised Statutes, 22-30.5-112.2,
3 **amend** (2)(a) and (3); and **add** (2)(c) and (5) as follows:

4 **22-30.5-112.2. Charter schools - at-risk supplemental aid -**
5 **definitions - legislative declaration - repeal.** (2) (a) For the 2012-13
6 budget year ~~and each budget year thereafter~~ THROUGH THE 2024-25
7 BUDGET YEAR, the general assembly shall appropriate to the department
8 of education for allocation to school districts the amount calculated for
9 at-risk supplemental aid for those school districts and district charter
10 schools described in ~~paragraph (b) of this subsection (2)~~ SUBSECTION
11 (2)(b) OF THIS SECTION. FOR THE 2025-26 BUDGET YEAR AND THE 2026-27
12 BUDGET YEAR, THE GENERAL ASSEMBLY SHALL APPROPRIATE TO THE
13 DEPARTMENT OF EDUCATION FOR ALLOCATION TO SCHOOL DISTRICTS THE
14 AMOUNT DETERMINED FOR SUPPLEMENTAL AID FOR THOSE SCHOOL
15 DISTRICTS AND DISTRICT CHARTER SCHOOLS DESCRIBED IN SUBSECTION
16 (2)(c) OF THIS SECTION. The at-risk supplemental aid is additional funding
17 and does not supplant any other funding provided pursuant to this article.

18 (c) FOR THE 2025-26 BUDGET YEAR, EACH SCHOOL DISTRICT AND
19 DISTRICT CHARTER SCHOOL'S AT-RISK SUPPLEMENTAL AID IS THE SAME
20 AMOUNT THAT IT RECEIVED IN THE 2024-25 BUDGET YEAR. FOR THE
21 2026-27 BUDGET YEAR, EACH SCHOOL DISTRICT AND DISTRICT CHARTER
22 SCHOOL'S AT-RISK SUPPLEMENTAL AID IS FIFTY PERCENT OF THE AMOUNT
23 THAT IT RECEIVED IN THE 2024-25 BUDGET YEAR.

24 (3) If the appropriation to the department of education is
25 insufficient to fund ~~one hundred percent of~~ the at-risk supplemental aid
26 ~~calculated pursuant to paragraph (b) of subsection (2)~~ DETERMINED
27 PURSUANT TO SUBSECTION (2) of this section, the department of education
28 shall reduce each school district's and each district charter school's at-risk
29 supplemental aid proportionately.

30 (5) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2028.

31 **SECTION 3.** In Colorado Revised Statutes, 22-30.5-513, **amend**
32 (4.5)(a) and (4.5)(d); and **add** (4.5)(b.5) and (4.5)(e) as follows:

33 **22-30.5-513. Institute charter schools - funding - at-risk**
34 **supplemental aid - legislative declaration - definitions - repeal.**
35 (4.5) (a) For the 2012-13 budget year ~~and each budget year thereafter~~
36 THROUGH THE 2024-25 BUDGET YEAR, the general assembly shall
37 appropriate to the charter school institute the amount calculated for at-risk
38 supplemental aid pursuant to ~~paragraph (b) of this subsection (4.5)~~
39 SUBSECTION (4.5)(b) OF THIS SECTION for each institute charter school
40 whose percentage of at-risk pupils is less than the percentage of at-risk

1 pupils in the accounting district. FOR THE 2025-26 BUDGET YEAR AND THE
2 2026-27 BUDGET YEAR, THE GENERAL ASSEMBLY SHALL APPROPRIATE TO
3 THE CHARTER SCHOOL INSTITUTE FOR ALLOCATION TO INSTITUTE CHARTER
4 SCHOOLS THE AMOUNT DESCRIBED IN SUBSECTION (4.5)(b.5) OF THIS
5 SECTION. At-risk supplemental aid is additional funding and does not
6 supplant any other funding allocated pursuant to this section. The charter
7 school institute shall pass through one hundred percent of an institute
8 charter school's at-risk supplemental aid to the institute charter school.

9 (b.5) FOR THE 2025-26 BUDGET YEAR, EACH INSTITUTE CHARTER
10 SCHOOL'S AT-RISK SUPPLEMENTAL AID IS THE SAME AMOUNT THAT IT
11 RECEIVED IN THE 2024-25 BUDGET YEAR. FOR THE 2026-27 BUDGET YEAR,
12 EACH INSTITUTE CHARTER SCHOOL'S AT-RISK SUPPLEMENTAL AID IS FIFTY
13 PERCENT OF THE AMOUNT THAT IT RECEIVED IN THE 2024-25 BUDGET
14 YEAR.

15 (d) If the appropriation to the charter school institute is
16 insufficient to fund ~~one hundred percent~~ of the at-risk supplemental aid
17 ~~calculated~~ DETERMINED pursuant to this subsection (4.5), the charter
18 school institute shall reduce each institute charter school's at-risk
19 supplemental aid proportionately.

20 (e) THIS SUBSECTION (4.5) IS REPEALED, EFFECTIVE JULY 1, 2028.
21 **SECTION 4.** In Colorado Revised Statutes, **repeal** 22-54-136.".
