SB25-290 be amended as follows:

- 4 "(3) "INFORMATION TECHNOLOGY REVOLVING FUND" MEANS THE
- 5 INFORMATION TECHNOLOGY REVOLVING FUND CREATED IN SECTION
- 6 24-37.5-103 (3)(a).".
- 7 Renumber succeeding subsections accordingly.
- 8 Page 6 of the bill, strike lines 23 and 24.
- 9 Page 6 of the bill, line 26, strike "(a)".
- 10 Page 7 of the bill, line 1, strike "(I)" and substitute "(a)" and strike "AS A
- 11 LOAN".
- 12 Page 7 of the bill, strike line 2 and substitute "INFORMATION TECHNOLOGY
- 13 REVOLVING FUND PURSUANT TO SECTION 24-37.5-103 (5);".
- 14 Page 7 of the bill, line 3, strike "(II)" and substitute "(b)".
- 15 Page 7 of the bill, line 5, strike "(III)" and substitute "(c)".
- 16 Page 7 of the bill, strike lines 7 through 27.
- 17 Page 8 of the bill, strike lines 1 through 6.".
- 18 Page 1 of the report, after line 11 insert:
- 19 "Strike page 14 of the bill.
- 20 Page 15 of the bill, strike lines 1 through 10 and substitute:
- 21 "SECTION 4. In Colorado Revised Statutes, 24-37.5-103, **add**
- 22 (5) as follows:
- 23 **24-37.5-103. Office of information technology - creation -**
- 24 **information technology revolving fund - geographic information**
- 25 **system coordination - repeal.** (5) (a) NOTWITHSTANDING ANY OTHER
- 26 PROVISION TO THE CONTRARY, ON JULY 1, 2025, THE STATE TREASURER

2 PROVIDER STABILIZATION FUND CREATED IN SECTION 25.5-3-603 (1) FOR
3 USE IN ACCORDANCE WITH PART 6 OF ARTICLE 3 OF TITLE 25.5.
4 (b) THIS SUBSECTION (5) IS REPEALED, EFFECTIVE JULY 1, 2027."."
