PURPOSE: Reduces appropriations related to prison caseload adjustment in the Department of **Corrections** by \$3,489,416 General Fund. Adds \$363,038 General Fund for reentry workforce development in the Department of **Corrections**. Adds \$363,038 General Fund for the Colorado Child Care Assistance Program in the Department of **Early Childhood** and a footnote stating the General Assembly's intent that those funds be directed to individuals undergoing treatment for substance use disorder. Adds \$28,657 General Fund for forensic services in the Department of **Human Services**. Adds \$1,684,683 General Fund to the **Judicial** Department for General Courts Administration and for Statewide Behavioral Health Court Liaison. Adds \$1,050,000 General Fund for the Targeted Crime Reduction program in the Department of **Local Affairs**.
