

SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Winter F.

1 Amend printed bill, page 3, line 7, strike "HAS" and substitute "AND
2 "MEMBER IN THIS STATE" HAVE".

3 Page 4, line 1, strike "THE ONLINE DATING SERVICE" and substitute "AN
4 ONLINE DATING SERVICE THAT HAS A MEMBER LOCATED IN THIS STATE ON
5 THE EFFECTIVE DATE OF THIS SECTION".

6 Page 4, line 2, after "2025." insert "AN ONLINE DATING SERVICE THAT
7 REGISTERS ITS FIRST MEMBER IN THIS STATE AFTER THE EFFECTIVE DATE
8 OF THIS SECTION SHALL MAKE THE SAFETY POLICY EFFECTIVE ONE YEAR
9 AFTER IT REGISTERS ITS FIRST MEMBER IN THIS STATE.".

10 Page 4, after line 17 insert:

11 "(d) A DESCRIPTION OF WHETHER THE ONLINE DATING SERVICE
12 PERMITS A MEMBER WHO WAS SUSPENDED OR BARRED AS A RESULT OF
13 REPORTS OF PROHIBITED CONTENT AND CONDUCT COMMITTED BY THE
14 MEMBER TO APPEAL THE ADVERSE ACTION AND, IF THE ONLINE DATING
15 SERVICE PERMITS AN APPEAL, THE APPEAL PROCESS;".

16 Reletter succeeding paragraphs accordingly.

17 Page 6, after line 13 insert:

18 "(6) PRIOR TO COMMENCING AN ENFORCEMENT ACTION PURSUANT
19 TO THIS ARTICLE 1 AGAINST AN ONLINE DATING SERVICE THAT REGISTERS
20 ITS FIRST MEMBER IN THIS STATE AFTER THE EFFECTIVE DATE OF THIS
21 SECTION FOR THE SERVICE'S FIRST VIOLATION OF THIS SECTION, THE
22 ATTORNEY GENERAL OR A DISTRICT ATTORNEY MUST ISSUE A NOTICE OF
23 VIOLATION TO THE ONLINE DATING SERVICE IF THE ATTORNEY GENERAL OR
24 DISTRICT ATTORNEY DETERMINES THAT IT IS POSSIBLE FOR THE ONLINE
25 DATING SERVICE TO CURE THE VIOLATION. IF THE ONLINE DATING SERVICE
26 FAILS TO CURE THE VIOLATION WITHIN THIRTY DAYS OF RECEIVING THE
27 NOTICE OF VIOLATION, THE ATTORNEY GENERAL OR DISTRICT ATTORNEY
28 MAY BRING AN ENFORCEMENT ACTION PURSUANT TO THIS ARTICLE 1.".

29 Renumber succeeding subsection accordingly.

30 Amend the Judiciary Committee Report, dated March 11, 2024, page 4,
31 line 17, strike "SECTION.". and substitute "SECTION. THE RULES MAY
32 INCLUDE THE PROCESS FOR AN ONLINE DATING SERVICE TO SUBMIT TO THE
33 ATTORNEY GENERAL'S OFFICE THE URL FOR ITS SAFETY POLICY.".
