

SENATE COMMITTEE OF REFERENCE AMENDMENT
Committee on Judiciary.

SB24-011 be amended as follows:

1 Amend printed bill, page 5, strike lines 12 through 22 and substitute:

2 "(3) AN ONLINE DATING SERVICE SHALL POST A CLEAR AND
3 CONSPICUOUS LINK TO THE SERVICE'S SAFETY POLICY ON THE MAIN PAGE
4 OF ITS WEBSITE AND ON THE SETTINGS, OR A SIMILAR SCREEN, OF ITS
5 MOBILE APPLICATION, IF APPLICABLE, AND INCLUDE A LINK TO THE SAFETY
6 POLICY IN A DATING SERVICE CONTRACT DESCRIBED IN SECTION 6-1-731.
7 THE TEXT OF EACH LINK MUST EXPLICITLY INFORM A COLORADO MEMBER
8 THAT THE LINK NAVIGATES THE MEMBER TO THE ONLINE DATING SERVICE'S
9 SAFETY POLICY.

10 (4) (a) AN ONLINE DATING SERVICE SHALL SUBMIT THE URL FOR
11 ITS SAFETY POLICY POSTED ON ITS WEBSITE TO THE ATTORNEY GENERAL'S
12 OFFICE WITHIN FIFTEEN DAYS AFTER ENACTING THE SAFETY POLICY. IF AN
13 ONLINE DATING SERVICE UPDATES THE URL FOR ITS SAFETY POLICY, IT
14 SHALL SUBMIT THE UPDATED URL TO THE ATTORNEY GENERAL'S OFFICE
15 WITHIN SEVEN DAYS AFTER UPDATING THE URL.".

16 Page 6, line 2, strike "ABOUT MISCONDUCT COMMITTED BY A MEMBER,".

17 Page 6, line 4, after "NUMBER" insert "AND PERCENTAGE".

18 Page 6, line 7, after "NUMBER" insert "AND PERCENTAGE".

19 Page 6, after line 9 insert:

20 "(c) THE REPORT REQUIRED PURSUANT TO SUBSECTION (4)(b) OF
21 THIS SECTION IS ONLY REQUIRED TO INCLUDE INFORMATION ABOUT A
22 MEMBER LOCATED IN, OR REPORTS MADE BY A MEMBER LOCATED IN,
23 COLORADO, IF THAT INFORMATION IS AVAILABLE. IF THAT INFORMATION
24 IS NOT AVAILABLE, THE REPORT MUST INCLUDE INFORMATION FROM THE
25 ENTIRE UNITED STATES.".
