Committee on Finance.

HB24-1312 be amended as follows:

- 1 Amend printed bill, page 2, line 14, strike "WORKFORCE." and substitute
- 2 "WORKFORCE PROVIDING DIRECT CARE."
- 3 Page 3, line 1, strike "CHILD CARE WORKER,".
- 4 Page 3, line 4, strike "ASSISTANT, OR" and substitute "AIDE,".
- 5 Page 3, strike lines 5 and 6, and substitute "OR A CHILD CARE WORKER
- 6 WHO HAS BEEN EITHER THE LICENSEE OF AN ELIGIBLE PROGRAM OR
- 7 EMPLOYED BY AN ELIGIBLE PROGRAM FOR AT LEAST SIX MONTHS OF THE
- 8 INCOME TAX YEAR, OR AN INFORMAL FAMILY FRIEND OR NEIGHBOR CHILD
- 9 CARE WORKER AS DESCRIBED IN SECTION 26.5-5-304 (1)(f) WHO
- 10 NOTWITHSTANDING THE REQUIREMENT OF SUBSECTION (3)(b)(II) OF THIS
- 11 SECTION, PROVIDES CARES AT LEAST TWENTY HOURS A WEEK DURING AT
- 12 LEAST THIRTY-SIX WEEKS OF THE PRECEDING YEAR OR AT LEAST SEVEN
- 13 HUNDRED AND TWENTY TOTAL HOURS IN THE PRECEDING YEAR CARING
- 14 FOR CHILDREN OTHER THAN THEIR OWN, AND WHO IS REGISTERED WITH
- 15 THE DEPARTMENT OF EARLY CHILDHOOD'S COLORADO SHINES
- 16 PROFESSIONAL DEVELOPMENT INFORMATION SYSTEM (PDIS)."
- 17 Page 3, line 9, strike "JANUARY 1, 2024," and substitute "JANUARY 1,
- 18 2025," and strike "JANUARY 1, 2029," and substitute "JANUARY 1, 2030,".
- 19 Page 3, line 18, strike "ANNUAL" and substitute "ADJUSTED".
- 20 Page 3, line 25, after "(4)" insert "(a)".
- 21 Page 3, after line 27 insert:
- 22 "(b) NO LATER THAN JANUARY 1, 2026, AND EACH JANUARY 1
- 23 THEREAFTER THROUGH JANUARY 1, 2030, THE DEPARTMENT OF EARLY
- 24 CHILDHOOD MUST PROVIDE THE DEPARTMENT OF REVENUE WITH AN
- 25 ELECTRONIC REPORT OF EACH INDIVIDUAL WHO IS REGISTERED WITH THE
- 26 DEPARTMENT OF EARLY CHILDHOOD'S COLORADO SHINES PROFESSIONAL
- 27 DEVELOPMENT INFORMATION SYSTEM (PDIS) DURING THE PREVIOUS
- 28 CALENDAR YEAR FOR WHICH THE CREDIT IS ALLOWED."
- 29 Page 4, line 5, strike "DECEMBER 31, 2034." and substitute "DECEMBER
- 30 31, 2035."
