HB25-1222 be amended as follows:

1 Amend printed bill, page 6, strike lines 22 through 27.

2 Page 7, strike lines 1 and 2 and insert:

3 "(g) WHEN SUBJECTING A RURAL INDEPENDENT PHARMACY TO A
4 RECOUPMENT OF FUNDS OF MORE THAN ONE THOUSAND DOLLARS OR A
5 PENALTY OF MORE THAN ONE THOUSAND DOLLARS AS THE RESULT OF AN
6 AUDIT:

7 (I) ELECTRONICALLY NOTIFY THE RURAL INDEPENDENT PHARMACY
8 OF THE RURAL INDEPENDENT PHARMACY'S RIGHTS TO APPEAL PURSUANT
9 TO SUBSECTION (1)(e) OF THIS SECTION AT LEAST THIRTY DAYS BEFORE
10 THE RECOUPMENT OF FUNDS;

11 (II) IF THE RURAL INDEPENDENT PHARMACY DOES NOT RESPOND
12 TO THE ELECTRONIC NOTIFICATION PROVIDED PURSUANT TO SUBSECTION
13 (1)(g)(I) OF THIS SECTION WITHIN THIRTY DAYS AFTER THE ELECTRONIC
14 NOTIFICATION, AGAIN ELECTRONICALLY NOTIFY THE RURAL INDEPENDENT
15 PHARMACY OF THE RURAL INDEPENDENT PHARMACY'S RIGHTS TO APPEAL
16 PURSUANT TO SUBSECTION (1)(e) OF THIS SECTION AT LEAST THIRTY DAYS
17 BEFORE THE RECOUPMENT OF FUNDS; AND

18 (III) IF THE RURAL INDEPENDENT PHARMACY DOES NOT RESPOND
19 TO THE SECOND ELECTRONIC NOTIFICATION PROVIDED PURSUANT TO
20 SUBSECTION (1)(g)(II) OF THIS SECTION WITHIN THIRTY DAYS AFTER THE
21 SECOND ELECTRONIC NOTIFICATION, SERVE PROCESS ON THE RURAL
22 INDEPENDENT PHARMACY NOTIFYING OF THE RURAL INDEPENDENT
23 PHARMACY'S RIGHTS TO APPEAL PURSUANT TO SUBSECTION (1)(e) OF THIS
24 SECTION AT LEAST THIRTY DAYS BEFORE THE RECOUPMENT OF FUNDS.".
