NOTIFICATION OF OIL AND GAS INCIDENTS INVOLVING HAZARDOUS CHEMICALS

24-32-3701. Short title. THE SHORT TITLE OF THIS PART 37 IS THE "COMMUNITY RIGHT TO KNOW ACT".

10 **24-32-3702. Legislative declaration.** (1) THE GENERAL
11 ASSEMBLY FINDS THAT:

12 (a) THERE WERE THREE THOUSAND SIX HUNDRED TWENTY-EIGHT
13 INCIDENTS REPORTED BY OPERATORS TO THE COMMISSION BETWEEN 2019
14 AND 2023;

15 (b) THE NUMBER OF REPORTED INCIDENTS HAS INCREASED EACH
16 YEAR, WITH FOUR HUNDRED SEVENTY-SIX INCIDENTS IN 2020, EIGHT
17 HUNDRED FIFTY-FOUR INCIDENTS IN 2021, ONE THOUSAND ONE HUNDRED
18 SIX INCIDENTS IN 2022, AND ONE THOUSAND ONE HUNDRED NINETY-TWO
19 INCIDENTS IN 2023;

20 (c) CERTAIN CHEMICALS THAT ARE ACCIDENTALLY DISCHARGED,
21 EMITTED, RELEASED, OR SPILLED AS A RESULT OF OIL AND GAS
22 OPERATIONS CAN HAVE AN ADVERSE IMPACT ON PUBLIC HEALTH, SAFETY,
23 AND WELFARE; THE ENVIRONMENT; AND WILDLIFE RESOURCES;

24 (d) EXPOSURE TO A HAZARDOUS CHEMICAL MAY RESULT IN
25 ADVERSE SHORT-TERM AND LONG-TERM HEALTH IMPACTS, PARTICULARLY
26 FOR THOSE INDIVIDUALS IN CLOSE PROXIMITY TO AN INCIDENT; AND

27 (e) MEDICAL PROFESSIONALS WHO TREAT INDIVIDUALS SUFFERING
28 FROM SHORT-TERM AND LONG-TERM ADVERSE HEALTH IMPACTS FROM
29 HAZARDOUS CHEMICALS OFTEN DO NOT HAVE ENOUGH INFORMATION
30 ABOUT AN INCIDENT TO BE ABLE TO EFFECTIVELY TREAT A PATIENT.

31 (2) THE GENERAL ASSEMBLY THEREFORE DETERMINES AND
32 DECLARER THAT:

33 (a) THE PUBLIC HAS A RIGHT TO BE INFORMED ABOUT HAZARDOUS
34 CHEMICALS THAT ARE INVOLVED IN AN INCIDENT; AND

35 (b) THE CREATION OF A WEBSITE FOR MEDICAL PROFESSIONALS
36 AND THE PUBLIC WITH INFORMATION ABOUT HAZARDOUS CHEMICALS THAT
37 ARE INVOLVED IN AN INCIDENT IS A MATTER OF STATEWIDE AND LOCAL
38 CONCERN AND IN THE PUBLIC INTEREST.

- record retention requirements.** (1) ON AND AFTER JULY 1, 2024, IN THE EVENT OF AN INCIDENT, IN ADDITION TO SUBMITTING A COVERED REPORT TO THE DIRECTOR OF THE COMMISSION PURSUANT TO COMMISSION RULES, AN OPERATOR SHALL, WITHIN TWENTY-FOUR HOURS AFTER THE DISCOVERY OF AN INCIDENT, ALSO SUBMIT THE COVERED REPORT TO THE PERSON DESIGNATED BY THE EXECUTIVE DIRECTOR OF THE DEPARTMENT PURSUANT TO SUBSECTION (2)(a) OF THIS SECTION.

5 (b) UPON REQUEST BY THE DEPARTMENT, PROVIDE THE RECORDS
6 DESCRIBED IN SUBSECTION (3)(a) OF THIS SECTION TO THE DEPARTMENT
7 FOR THE PURPOSES OF A HAZARDOUS CHEMICAL NOTIFICATION REPORT.

11 (2) (a) THE COMMITTEE CONSISTS OF THE FOLLOWING MEMBERS:

12 (I) FOUR PHYSICIANS, APPOINTED BY THE GOVERNOR, WHO HAVE
13 EXPERIENCE:

14 (A) IN EPIDEMIOLOGY, ONCOLOGY, ENDOCRINOLOGY,
15 PULMONOLOGY, TOXICOLOGY, OR TREATING PATIENTS WITH MEDICAL
16 TRAUMA; AND

17 (B) TREATING PATIENTS WHO ARE LOCATED IN, OR ARE PART OF,
18 A DISPROPORTIONATELY IMPACTED COMMUNITY;

19 (II) THE INDIVIDUAL DESIGNATED BY THE EXECUTIVE DIRECTOR OF
20 THE DEPARTMENT PURSUANT TO SECTION 24-32-3704 (2)(a);

21 (III) ONE MEMBER REPRESENTING THE COMMISSION, APPOINTED BY

24 HAZARDOUS CHEMICAL LISTED:

25 MONTHLY BASIS DURING THE FIRST YEAR AFTER THE FIRST APPOINTMENTS

26 TO THE COMMITTEE ARE MADE TO:

27 (I) DEVELOP CONTENT FOR THE WEBSITE IN ACCORDANCE WITH

28 THE REQUIREMENTS DESCRIBED IN SUBSECTION (3) OF THIS SECTION; AND

24-32-3706. Enforcement - penalties - waiver of liability.
