HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

HB24-1447 be amended as follows:

1 Amend proposed committee amendment (HB 1447_L.003), page 1, line
2 2, strike "8." and substitute "8 and substitute:

3 "SECTION 1. In Colorado Revised Statutes, 32-9-103, **add**
4 (14.5) as follows:

5 **32-9-103. Definitions.** As used in this article 9, unless the context
6 otherwise requires:

7 (14.5) "UNDERSERVED COMMUNITY" MEANS A MUNICIPALITY THAT
8 IS WITHIN THE DISTRICT BOUNDARY AREA AND, OVER A FIVE-YEAR
9 AVERAGE, GENERATES THREE TIMES OR MORE REVENUE FOR THE DISTRICT
10 THAN THE TOTAL VALUE OF TRANSPORTATION SERVICES PROVIDED TO
11 THAT MUNICIPALITY."."

12 Page 1 of the amendment, strike line 3.

13 Page 1 of the amendment, after line 6 insert:

14 "Page 8 of the bill, line 25, strike "PLAN;" and substitute "PLAN, WHILE
15 TAKING INTO ACCOUNT THE NEED TO EXPAND SERVICES TO UNDERSERVED
16 COMMUNITIES;"."

17 Page 2 of the amendment, strike line 10 and substitute:

18 "(c) ENSURE THAT UNDERSERVED COMMUNITIES HAVE
19 OPPORTUNITY TO ENGAGE IN CONVERSATIONS REGARDING THE TEN-YEAR
20 STRATEGIC PLAN IN A DEDICATED AND DELIBERATE MANNER OUTSIDE THE
21 CONFINES OF THE METROPOLITAN PLANNING ORGANIZATION;

22 (d) ADDRESS THE UNIQUE CONCERNS AND SERVICE NEEDS OF
23 DISPROPORTIONATELY IMPACTED COMMUNITIES, WHICH MUST BE
24 DEVELOPED THROUGH DEDICATED PUBLIC HEARINGS AND ENGAGEMENT
25 WITH STAFF, OFFICIALS, AND MEMBERS OF THE PUBLIC FROM THOSE
26 COMMUNITIES;

27 (e) ADDRESS THE UNIQUE CONCERNS AND SERVICE NEEDS OF
28 UNDERSERVED COMMUNITIES, WHICH MUST BE DEVELOPED THROUGH
29 DEDICATED PUBLIC HEARINGS AND ENGAGEMENT WITH STAFF, OFFICIALS,
30 AND MEMBERS OF THE PUBLIC FROM THOSE COMMUNITIES; AND"."
