

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB24-1325 be amended as follows:

1 Amend printed bill, page 16, line 4, strike "AND".

2 Page 16, line 7, after "STATE;" add "AND

3 (C) THE SUBMISSION OF A COMMUNITY BENEFITS PLAN DEVELOPED
4 BY A NONPROFIT ENTITY DESCRIBED IN SUBSECTION (6)(d)(I)(B) OF THIS
5 SECTION, THROUGH ENGAGEMENT WITH THE COMMUNITY SURROUNDING
6 THE SHARED QUANTUM FACILITY;".

7 Page 25, after line 19 insert:

8 "(c) WITHRESPECT TO MAKING THE PRELIMINARY DETERMINATION
9 AS TO WHETHER A PROJECT PLAN IS A PLAN FOR AN ELIGIBLE PROJECT
10 PURSUANT TO SUBSECTION (5)(b)(III) OF THIS SECTION, THE OFFICE SHALL
11 CONSIDER JOB QUALITY STANDARDS AND GUIDELINES FOR THE SHARED
12 QUANTUM FACILITY THAT ADHERE TO THE "GOOD JOBS PRINCIPLES"
13 ESTABLISHED BY THE UNITED STATES DEPARTMENT OF LABOR AND
14 UNITED STATES DEPARTMENT OF COMMERCE.".

15 Page 32, strike line 17 and substitute "ELIGIBLE LOAN, THE
16 ADMINISTRATOR SHALL DETERMINE THE AMOUNT OF THE REGISTRATION
17 AND ISSUANCE FEE DESCRIBED IN SUBSECTION (6)(a) OF THIS SECTION AS
18 UP TO EIGHT PERCENT OF THE AMOUNT THAT WILL BE SPECIFIED ON THE
19 TAX CREDIT CERTIFICATE AS DESCRIBED IN SUBSECTION (7)(d)(I) OF THIS
20 SECTION, AND SHALL COLLECT THE FEE FROM THE QUALIFIED APPLICANT
21 OR THE BORROWER TO WHICH A QUALIFIED APPLICANT MADE AN ELIGIBLE
22 LOAN. ONCE THE REGISTRATION AND ISSUANCE FEE IS COLLECTED, THE
23 ADMINISTRATOR SHALL REGISTER THE LOAN,".

24 Page 32, line 19, strike "SECTION." and substitute "SECTION, AND MAY
25 ISSUE THE TAX CREDIT CERTIFICATE AS SPECIFIED IN SUBSECTION (7) OF
26 THIS SECTION.".

27 Page 33, strike lines 17 through 25 and substitute:

28 **"(6) Registration and issuance fee.** (a) THE ADMINISTRATOR
29 SHALL IMPOSE ON AND COLLECT FROM A QUALIFIED APPLICANT OR THE
30 BORROWER TO WHICH A QUALIFIED APPLICANT MADE AN ELIGIBLE LOAN
31 A REASONABLE REGISTRATION AND ISSUANCE FEE PURSUANT TO
32 SUBSECTION (5)(c)(II) OF THIS SECTION.".
