Committee on Health & Human Services.

SB24-047 be amended as follows:

1 Amend reengrossed bill, page 12, before line 10 insert:

2 **"25-20.5-2203. Composition of overdose fatality review teams**  
3 **- required members - additional members - responsibilities of the**  
4 **chair. (1) EACH LOCAL TEAM MUST CONSIST OF AT LEAST FIVE OF THE**

5 FOLLOWING INDIVIDUALS, ORGANIZATIONS, AGENCIES, AND AREAS OF  
6 EXPERTISE, IF AVAILABLE; EXCEPT THAT THERE SHALL NOT BE MORE THAN  
7 ONE REPRESENTATIVE FROM LAW ENFORCEMENT:

8 (a) THE COUNTY OR DISTRICT HEALTH OFFICER, OR THE OFFICER'S  
9 DESIGNEE;

10 (b) THE DIRECTOR OF THE LOCAL DEPARTMENT OF HUMAN  
11 SERVICES, OR THE DIRECTOR'S DESIGNEE;

12 (c) THE LOCAL DISTRICT ATTORNEY, OR THE DISTRICT ATTORNEY'S  
13 DESIGNEE;

14 (d) THE DIRECTOR OF BEHAVIORAL HEALTH SERVICES IN THE  
15 COUNTY, OR THE DIRECTOR'S DESIGNEE;

16 (e) A STATE, COUNTY, OR MUNICIPAL LAW ENFORCEMENT OFFICER;

17 (f) A REPRESENTATIVE OF A LOCAL JAIL OR DETENTION CENTER;

18 (g) THE LOCAL MEDICAL EXAMINER OR CORONER, OR ITS DESIGNEE;

19 (h) A HEALTH-CARE PROVIDER WHO SPECIALIZES IN THE  
20 PREVENTION, DIAGNOSIS, AND TREATMENT OF SUBSTANCE USE DISORDERS;

21 (i) A MENTAL HEALTH PROVIDER WHO SPECIALIZES IN SUBSTANCE  
22 USE DISORDERS;

23 (j) A REPRESENTATIVE OF AN EMERGENCY MEDICAL SERVICES  
24 PROVIDER IN THE COUNTY;

25 (k) A REPRESENTATIVE FROM PAROLE, PROBATION, AND  
26 COMMUNITY CORRECTIONS;

27 (l) A REPRESENTATIVE FROM A HARM REDUCTION PROVIDER; AND

28 (m) A RECOVERY COACH, PEER SUPPORT WORKER, OR OTHER  
29 REPRESENTATIVE OF THE RECOVERY COMMUNITY."

30 Renumber succeeding C.R.S. sections accordingly.

31 Page 15, line 15, strike "2203," and substitute "2206,".
