

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB24-069 be amended as follows:

- 1 Amend printed bill, page 2, line 5, strike "**definitions.**" and substitute
2 "**definition.**".
- 3 Page 2, strike lines 6 and 7 and substitute "1, 2026, THE DEPARTMENT
4 SHALL CREATE, DELIVER, AND MAKE PUBLICLY AVAILABLE A TRAINING
5 PROGRAM. THE".
- 6 Page 2, lines 9 and 10, strike "TO SPECIAL EDUCATION ADVOCATES AND
7 PARENTS".
- 8 Page 2, strike lines 14 through 18 and substitute:
9 "(b) THE DEPARTMENT SHALL DELIVER THE TRAINING PROGRAM IN
10 PERSON AND MAKE THE TRAINING ACCESSIBLE ONLINE. THE GENERAL
11 ASSEMBLY ENCOURAGES ANYONE WHO WISHES TO PARTICIPATE TO".
- 12 Page 3, strike lines 7 through 9 and substitute:
13 "(I) A RECORDING OF THE TRAINING DELIVERED PURSUANT TO THIS
14 SECTION; AND".
- 15 Page 3, strike lines 16 through 25, and substitute:
16 "(3) UPON THE REQUEST OF A NONPROFIT ORGANIZATION, THE
17 DEPARTMENT SHALL PROVIDE A TRAIN-THE-TRAINER MODEL TRAINING TO
18 EMPLOYEES, VOLUNTEERS, OR AGENTS OF THE NONPROFIT ORGANIZATION.
19 THE DEPARTMENT SHALL PUBLISH, AND UPDATE AS NECESSARY ON ITS
20 WEBSITE, THE NAMES OF NONPROFIT ORGANIZATIONS THAT HAVE
21 EMPLOYEES, VOLUNTEERS, OR AGENTS WHO HAVE COMPLETED THE
22 TRAIN-THE-TRAINER MODEL TRAINING.
23 (4) UPON THE REQUEST OF ANY PERSON, THE DEPARTMENT SHALL
24 PROVIDE ANY RESOURCES OR MATERIALS DEVELOPED TO ACCOMPANY THE
25 TRAINING PROGRAM IN THE LANGUAGE REQUESTED BY THE PERSON.
26 (5) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
27 REQUIRES, "TRAIN-THE-TRAINER" MEANS A TRAINING FRAMEWORK THAT
28 DEVELOPS TRAINING RECIPIENTS INTO SUBJECT MATTER EXPERTS WHO ARE
29 THEN QUALIFIED TO DELIVER A TRAINING."
- 30 Page 1, line 102, strike "**INFORMATION.**" and substitute "**INFORMATION**
31 **THROUGH A PUBLICLY AVAILABLE TRAINING PROGRAM.**".
