

SENATE COMMITTEE OF REFERENCE AMENDMENT
Committee on Finance.

SB24-173 be amended as follows:

1 Amend printed bill, page 24, after line 19 insert:

2 "(4) (a) AN INDIVIDUAL LICENSED UNDER THIS PART 6 MAY
3 DELEGATE TASKS, AS DETERMINED BY THE DIRECTOR IN RULE, WITHIN THE
4 SCOPE OF THE INDIVIDUAL'S LICENSE TO UNLICENSED PERSONS PRACTICING
5 WITHIN THE UNLICENSED PERSON'S EXPERIENCE, EDUCATION, OR
6 TRAINING.

7 (b) A LICENSEE IS RESPONSIBLE FOR ENSURING THAT A DELEGATEE
8 HAS THE EXPERIENCE, EDUCATION, AND TRAINING NECESSARY TO
9 PERFORM DELEGATED TASKS.

10 (c) A LICENSEE RETAINS RESPONSIBILITY FOR ANY TASKS
11 DELEGATED UNDER THIS SUBSECTION (4).

12 (d) A LICENSEE SHALL NOT DELEGATE THE FOLLOWING TASKS:

13 (I) ANY TASK INVOLVING HANDLING HUMAN REMAINS; EXCEPT
14 THAT THIS SUBSECTION (4)(d)(I) DOES NOT APPLY TO TRANSPORTING
15 HUMAN REMAINS;

16 (II) SIGNING CONTRACTS OR OTHER LEGAL DOCUMENTS THAT
17 INVOLVE COMPENSATION FOR FUNERAL GOODS OR SERVICES; OR

18 (III) OVERSIGHT OF A FUNERAL HOME OR CREMATORIAL OPERATIONS
19 RELATED TO THE FINAL DISPOSITION OF HUMAN REMAINS.".

20 Page 26, after line 1 insert:

21 "(2) (a) AN INDIVIDUAL LICENSED UNDER THIS PART 7 MAY
22 DELEGATE TASKS, AS DETERMINED BY THE DIRECTOR IN RULE, WITHIN THE
23 SCOPE OF THE INDIVIDUAL'S LICENSE TO UNLICENSED PERSONS PRACTICING
24 WITHIN THE UNLICENSED PERSON'S EXPERIENCE, EDUCATION, OR
25 TRAINING.

26 (b) A LICENSEE IS RESPONSIBLE FOR ENSURING THAT A DELEGATEE
27 HAS THE EXPERIENCE, EDUCATION, AND TRAINING NECESSARY TO
28 PERFORM DELEGATED TASKS.

29 (c) A LICENSEE RETAINS RESPONSIBILITY FOR ANY TASKS
30 DELEGATED UNDER THIS SUBSECTION (2).

31 (d) A LICENSEE SHALL NOT DELEGATE THE FOLLOWING TASKS:

32 (I) ANY TASK INVOLVING HANDLING HUMAN REMAINS; EXCEPT
33 THAT THIS SUBSECTION (2)(d)(I) DOES NOT APPLY TO TRANSPORTING
34 HUMAN REMAINS;

35 (II) SIGNING CONTRACTS OR OTHER LEGAL DOCUMENTS THAT
36 INVOLVE COMPENSATION FOR FUNERAL GOODS OR SERVICES; OR

37 (III) OVERSIGHT OF A FUNERAL HOME OR CREMATORIAL OPERATIONS
38 RELATED TO THE FINAL DISPOSITION OF HUMAN REMAINS.".
