SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB20-101 be amended as follows:

1 Amend printed bill, page 2, line 4, strike "WITHIN" and substitute
2 "EXCEPT AS PROVIDED IN SUBSECTION (4)(c) OF THIS SECTION, WITHIN".

3 Page 3, after line 6, insert:

4 "(c) THIS SUBSECTION (4) DOES NOT APPLY TO COMPLAINTS
5 CONCERNING THE COMMERCIAL APPLICATION OF PESTICIDES ON A
6 MARIJUANA CROP."

7 Page 3, strike lines 13 and 14 and substitute:

8 "(6) NOTWITHSTANDING ARTICLE 80 OF TITLE 13, AND TO BRING
9 PROCEEDINGS TO IMPOSE DISCIPLINE, THE SUBJECT OF A COMPLAINT MUST BE
10 GIVEN THE NOTICE REQUIRED IN SECTION 24-4-104 (3) WITHIN ONE YEAR
11 AFTER A COMPLAINT IS INITIATED BY THE DEPARTMENT OR RECEIVED BY
12 THE DEPARTMENT, AND NOT THEREAFTER. THIS SUBSECTION (6) DOES NOT
13 APPLY TO COMPLAINTS CONCERNING THE COMMERCIAL APPLICATION OF
14 PESTICIDES ON A MARIJUANA CROP."

15 Page 3, strike lines 19 through 24 and substitute:

16 "(6) NOTWITHSTANDING ARTICLE 80 OF TITLE 13, AND TO BRING
17 PROCEEDINGS TO IMPOSE CIVIL PENALTIES, THE SUBJECT OF A COMPLAINT
18 MUST BE GIVEN THE NOTICE REQUIRED IN SECTION 24-4-104 (3) WITHIN
19 ONE YEAR AFTER A COMPLAINT IS INITIATED BY THE DEPARTMENT OR
20 RECEIVED BY THE DEPARTMENT, AND NOT THEREAFTER. THIS SUBSECTION
21 (6) DOES NOT APPLY TO PROCEEDING BASED ON A VIOLATION OF SECTION
22 35-10-117 (1)(a), (1)(b), OR (1)(c) OR BASED ON COMPLAINTS
23 CONCERNING COMMERCIAL APPLICATION OF PESTICIDES ON A MARIJUANA
24 CROP."

25 Page 4, strike lines 2 through 5 and substitute "SECTION MUST BE
26 COMMENCED WITHIN ONE YEAR AFTER A COMPLAINT IS INITIATED BY THE
27 DEPARTMENT OR RECEIVED BY THE DEPARTMENT, AND NOT THEREAFTER.
28 THIS SUBSECTION (4) DOES NOT APPLY TO A PROSECUTION BASED ON A
29 VIOLATION OF SECTION 35-10-117 (1)(a), (1)(b), OR (1)(c) OR BASED ON
30 COMPLAINTS CONCERNING COMMERCIAL APPLICATION OF PESTICIDES ON
31 A MARIJUANA CROP."
