1 Amend the Appropriations Committee Report, dated April 26, 2024, page
2 11, line 4, strike "(3)(b)(VI)(B)" and substitute "SUBSECTION
3 (3)(b)(VI)(D)".

4 Page 11 of the report, strike lines 5 through 22 and substitute:

5 "(B) FOR THE 2024-25 BUDGET YEAR, THE DEPARTMENT OF
6 EDUCATION, IN CONSULTATION WITH LEGISLATIVE COUNSEL STAFF, SHALL
7 CALCULATE FOR EACH DISTRICT THE AMOUNT EQUAL TO:

15 DISTRICT'S AT-RISK PUPIL ENROLLMENT FOR THE 2024-25 BUDGET
16 YEAR X TWELVE PERCENT
17 + (DISTRICT'S PER PUPIL FUNDING DETERMINED PURSUANT TO
18 SECTION 22-54-104 (3) - STATEWIDE BASE PER PUPIL FUNDING) X
19 DISTRICT'S ENGLISH LANGUAGE LEARNER PUPIL ENROLLMENT FOR
20 THE 2024-25 BUDGET YEAR X EIGHT PERCENT.

21 (C) FOR THE 2024-25 BUDGET YEAR, THE DEPARTMENT OF
22 EDUCATION, IN CONSULTATION WITH LEGISLATIVE COUNCIL STAFF, SHALL
23 CALCULATE FOR EACH DISTRICT THE AMOUNT EQUAL TO THE DISTRICT'S
24 COST OF LIVING FACTOR PLUS THE DISTRICT'S SIZE FACTOR FOR THE
25 2024-25 BUDGET YEAR CALCULATED PURSUANT TO SECTION 22-54-103.5
26 MULTIPLIED BY THE STATEWIDE BASE PER PUPIL FUNDING FOR THE 2024-25
27 BUDGET YEAR MULTIPLIED BY THE DISTRICT'S FUNDED PUPIL COUNT FOR
28 THE 2024-25 BUDGET YEAR EXCLUDING THE DISTRICT'S ONLINE PUPIL
29 ENROLLMENT AND THE DISTRICT'S EXTENDED HIGH SCHOOL PUPIL
30 ENROLLMENT.

31 (D) THE DEPARTMENT OF EDUCATION SHALL COMPARE FOR EACH
32 DISTRICT THE AMOUNTS CALCULATED PURSUANT TO SUBSECTIONS
33 (3)(b)(VI)(B) AND (3)(b)(VI)(C) OF THIS SECTION. IF THE AMOUNT
34 CALCULATED PURSUANT TO SUBSECTION (3)(b)(VI)(C) OF THIS SECTION
35 IS LESS THAN THE AMOUNT CALCULATED PURSUANT TO SUBSECTION
36 (3)(b)(VI)(B) OF THIS SECTION, THE DEPARTMENT OF EDUCATION SHALL
37 DETERMINE THE DOLLAR AMOUNT DIFFERENCE BETWEEN THE AMOUNTS
38 CALCULATED PURSUANT TO SUBSECTIONS (3)(b)(VI)(B) AND
39 (3)(b)(VI)(C) OF THIS SECTION DIVIDE THAT DOLLAR AMOUNT DIFFERENCE
40 BY THE DISTRICT'S TOTAL PROGRAM FOR THE 2024-25 BUDGET YEAR AND

1 ADD THAT PERCENTAGE TO THE DISTRICT'S MILL LEVY OVERRIDE CAP FOR
2 THE 2023-24 BUDGET YEAR.
3 (E) THE DEPARTMENT OF EDUCATION SHALL MAKE
4 DETERMINATIONS PURSUANT TO SUBSECTIONS (3)(b)(VI)(B),
5 (3)(b)(VI)(C), AND (3)(b)(VI)(D) OF THIS SECTION AFTER IT MAKES
6 MID-YEAR REVISIONS TO REPLACE PROJECTIONS WITH ACTUAL FIGURES
7 WHEN DETERMINING EACH DISTRICT'S TOTAL PROGRAM FOR THE 2024-25
8 BUDGET YEAR.
9 (F) ON OR AFTER JULY 1, 2030, A DISTRICT SHALL NOT SUBMIT A
10 QUESTION TO THE ELIGIBLE ELECTORS OF THE DISTRICT PURSUANT TO THIS
11 SUBSECTION (3)(b)(VI).".".
