

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB24-080 be amended as follows:

- 1    Amend printed bill, page 4, lines 13 and 14, strike "LAWS AND SHALL  
2    MAKE" and substitute "LAWS, INCLUDING MAKING".
- 3    Page 4 of the bill, line 16, strike "INFORMATION THAT" and substitute  
4    "INFORMATION.".
- 5    Page 4 of the bill, strike lines 17 through 25.
- 6    Page 5 of the bill, strike line 9 and substitute "SUBSECTION (3) THAT  
7    ALIGN, TO THE EXTENT PRACTICABLE, WITH THE CARRIER PRICE  
8    TRANSPARENCY LAWS AND ANY SUBSEQUENT GUIDANCE FROM THE  
9    FEDERAL CENTERS FOR MEDICARE AND MEDICAID SERVICES.".
- 10    Amend the Health and Human Services Committee Report, dated  
11    February 22, 2024, page 1, line 7, after "2025," insert "AND EVERY SIX  
12    MONTHS THEREAFTER,".
- 13    Page 1 of the report, line 8, after "2025," insert "AND EVERY SIX MONTHS  
14    THEREAFTER,".
- 15    Page 5 of the bill, after line 22 insert:

16         "(b) INFORMATION SUBMITTED BY HEALTH INSURERS AND  
17         PHARMACY BENEFIT MANAGERS TO THE DIVISION IN ACCORDANCE WITH  
18         SUBSECTION (4)(a) OF THIS SECTION IS SUBJECT TO PUBLIC INSPECTION  
19         UNDER THE "COLORADO OPEN RECORDS ACT", PART 2 OF ARTICLE 72 OF  
20         TITLE 24.".
- 21    Reletter succeeding paragraphs accordingly.
- 22    Page 5 of the bill, line 23, strike "THE" and substitute "ON OR BEFORE  
23    JANUARY 1, 2025, THE".
- 24    Page 5 of the bill, line 24, after "PROCESS" insert "THAT INCLUDES  
25    REPRESENTATIVES FROM CARRIERS REGULATED IN THIS STATE THAT ARE  
26    REQUIRED TO PRODUCE THE PRICE-TRANSPARENCY FILES," and strike  
27    "TEMPLATE" and substitute "TEMPLATE, INCLUDING THE FORMAT AND  
28    METHOD OF SUBMISSION,".
- 29    Page 1 of the report, line 20 strike "TREASURY."." and substitute  
30    "TREASURY. THE DATA AND FORMAT OF THE SUBMISSION SHALL NOT BE

1 MATERIALLY DIFFERENT FROM THE DATA THAT CARRIERS ARE REQUIRED  
2 TO SUBMIT UNDER THE FEDERAL CARRIER PRICE TRANSPARENCY LAWS.  
3 SUBMISSION OF COLORADO-SPECIFIC DATA SHALL NOT BE CONSIDERED A  
4 MATERIAL DIFFERENCE.

5 (d) THE COMMISSIONER SHALL PROMULGATE RULES TO IMPLEMENT  
6 THIS SUBSECTION (4).".

7 Reletter succeeding paragraph accordingly.".

8 Page 5 of the bill, line 27, strike "ON".

9 Page 6 of the bill, line 1, strike "AT MINIMUM A MONTHLY BASIS." and  
10 substitute "AT LEAST EVERY SIX MONTHS.".
