1 Amend the Finance Committee Report, dated April 18, 2024, page 6, line
2 12, strike "10" and substitute "8".

3 Page 6, strike lines 14 through 35.

4 Page 7, strike lines 1 through 11 and substitute:

5 ""(b) NINE VOTING MEMBERS APPOINTED BY THE GOVERNOR, WHO
6 SERVE AT THE PLEASURE OF THE GOVERNOR, INCLUDING:

7 (I) AT LEAST THREE MEMBERS WITH EXPERIENCE IN AS MANY OF
8 THE FOLLOWING AREAS AS POSSIBLE:

9 (A) ALCOHOL USE DISORDER PREVENTION PROGRAMS AND
10 SERVICES, INCLUDING SCHOOL-BASED PREVENTION EFFORTS ALCOHOL USE
11 DISORDER TREATMENT PROGRAMS AND SERVICES;

12 (B) ALCOHOL USE DISORDER RECOVERY PROGRAMS AND SERVICES;

13 (C) PROVIDING YOUTH MENTAL HEALTH SERVICES, SUCH AS A
14 SOCIAL WORKER, A CHILD AND ADOLESCENT PSYCHIATRIST, OR OTHER
15 PROFESSIONAL SPECIALIZING IN CARING FOR YOUTH, WITH EXPERTISE IN
16 YOUTH ALCOHOL USE PREVENTION, TREATMENT, OR RECOVERY; OR

17 (D) IMPAIRED DRIVING PREVENTION AND DETERRENCE, INCLUDING
18 EXPERIENCE IN LAW ENFORCEMENT;

19 (II) AT LEAST THREE MEMBERS WHO MEET AS MANY OF THE BELOW
20 CRITERIA AS POSSIBLE:

21 (A) HAVE EXPERIENCED AN ALCOHOL USE DISORDER;

22 (B) HAVE A FAMILY MEMBER WHO HAS EXPERIENCED AN ALCOHOL
23 USE DISORDER OR FETAL ALCOHOL SPECTRUM DISORDER; OR

24 (C) REPRESENT AN ADVOCACY ORGANIZATION FOR PEOPLE WITH
25 MENTAL HEALTH CONDITIONS AND ALCOHOL AND RELATED SUBSTANCE
26 USE DISORDERS; AND

27 (III) AT LEAST THREE MEMBERS WHO REPRESENT THE ALCOHOL
28 INDUSTRY, INCLUDING ONE MEMBER REPRESENTING THE VINOUS LIQUOR
29 INDUSTRY, ONE MEMBER REPRESENTING THE SPIRITUOUS LIQUOR
30 INDUSTRY, AND ONE MEMBER REPRESENTING THE MALT LIQUOR
31 INDUSTRY."."
